2. It transpires from the records that the petitioner has not applied for grant of No Objection Certificate before the Competent Authority.

3. The Hon'ble Supreme Court in Civil Appeal No. 3945 of 2018 in case of Sisters of St. Joseph of Cluny vs. The State of West Bengal and Ors. vide order dated 18.04.2018, has held that any person who desires to establish a minority educational institution after the amendment Act of 2006 came into force, must apply only to the competent authority for grant of No Objection Certificate for the said purpose.

4. All applications for the establishment of a minority educational institution after the amendment Act of 2006 must go to the competent authority set up under the statute.

5. The petition is incomplete as the petitioner has not supplied complete information against Col. No. 1 (c) and 6 (a) of the petition. Also the petitioner has not filed Resolution along with the petition.

6. As the petitioner institution has not applied to the competent authority for grant of No Objection Certificate, this application is not maintainable at this stage. Accordingly, the petition is dismissed in default. Petitioner may be informed accordingly.
