Though this case is listed for final arguments, it has been observed from the physical inspection report that during the academic year 2022-23, out of total 1230 students of the petitioner institution, 15 students were from the Muslim minority community, 13 students were from the Christian minority community, 05 students were from the Sikh minority community, 04 students were from the Jain minority community and 1193 students were Hindu. In the academic year, 2023-24, out of total 1544 students of the petitioner institution, 17 students were from the Muslim minority community, 15 students were from the Christian minority community, 06 students were from the Sikh minority community, 05 students were from the Jain minority community and 1501 students were Hindu. During the academic year 2024-25, out of total 1740 students of the petitioner institution, 19 students are from the Muslim minority community, 16 students are from the Christian minority community, 07 students are from the Sikh minority community, 05 students are from the Jain minority community and 1693 students are Hindu.

It appears that the number of Christian students has been decreasing in the last few years. Learned counsel for the petitioner submitted that admission of students for the academic year 2025-26 has already been completed and it has been found that during this period the number of students from Christian minority community has increased.

Before passing a final order in this case, it would be appropriate to obtain physical inspection report from the members of physical inspection committee for the academic year 2025-26 of the petitioner institution.

Relying on the said unrebutted evidence produced on behalf of the petitioner, we find and hold that the Sharda University, Greater Noida, Plot No. 32, 34 Knowledge Park – III, Greater Noida, Uttar Pradesh, run by the Sharda Educational Trust, is eligible for grant of minority status on religious basis. The evidence also proves that the said educational institution was established with the main objective of sub-serving the interests of the Jain minority community.

Consequently, Sharda University, Greater Noida, Plot No. 32, 34 Knowledge Park – III, Greater Noida, Uttar Pradesh, is declared as an Unaided minority educational institution covered under Article 30 of the Constitution of India within the meaning of Section 2(g) of the National Commission for Minority Educational Institutions Act, 2004 subject to the condition that the petitioner would file an affidavit or undertaking to the fact that the petitioner University shall not deny admission of eligible candidate of the Jain minority community subject to the eligibility of the students and availability of the accommodation in the petitioner institution. If the petitioner University failed to comply the above order of this Commission within a period of three months from the date of order passed by this Commission then the petition filed by the petitioner for grant of MSC will be automatically deemed to be dismissed.

After compliance of the above order, a minority status certificate be issued accordingly.

In view of the above, the present petition is disposed of in accordance with this order.
