An application has been received by hand on 16.4.2025 from Mr. Tariq Adeeb, Advocate for grant of minority status certificate to St. Mary's School, Doom Dooma, Rupaisiding, District Tinsukia, Assam- 786153. It be registered.

2. It transpires from the petition that on 21.7.2023, the petitioner institution has applied for grant of No Objection Certificate to the State Competent Authority i.e. Joint Secretary, Education Department (Higher), Assam Secretariat, Block C, Secretariat Complex, Dispur, Guwahati, Assam- 781 006, which was received by the respondent on 25.7.2023. The said petition is still pending as per the petitioner institution. The petitioner has waited sufficiently for period of 90 days as per Section 10 of NCMEI Act, 2004, before filing this petition. The petitioner has not filed the proof of delivery of track consignment to the respondent.

3. The petitioner has filed notarized Copy of letter dated 15.6.2023 issued by Director of Secondary Education, Assam regarding registering the petitioner institution.

4. Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

5. It also transpires from the petition that the petitioner Institute is an unaided institution (Secondary).

6. During the academic year 2022-23, out of total 1642 students, 90 students were from the Christian minority community and in the academic year 2023-24, out of total 1561 students, 72 students were from the Christian minority community and in the year 2024-25, out of total 1564, 110 students were from the Christian minority community.

7. As per Notice dated 10.5.2024 issued by Commission in F. No. 3-2/2020-NCMEI mentioning therein that the petitioner institution should apply for MSC within nine months from the date of submitting NOC application before the State Competent Authority. Hence, the petition is not maintainable.

8. Learned Counsel for the petitioner seeks leave to withdraw the petition with liberty to file a fresh petition for the same relief. Leave and liberty is granted.

9. The petition is disposed of as withdrawn. Office is directed to return original set, envelope and postage charges to the learned counsel for the petitioner after retaining a copy. Record of Case No. 42 of 2022 be tagged with the record of this case.
