Members of the Physical Inspection Committee have sent a copy of the physical inspection report which was received by post before the Commission's office on 28.2.2025. The same is taken on record.

It is stated in the physical inspection report that Society member community details are not submitted by the institution, governing body members' religion status is not submitted by the institution, repeatedly informed the management of the institution to submit the above documents but the institution authorities not turned up and not submitted the same to the physical inspection committee, students complete community details are not provided so far. Due to non-submission of the above documents & information during physical inspection the proposal is not recommended for grant of minority status.

Section 2(c) of the National Commission for Minorities Act, 1992 defines a "Minority" as a community notified as such by the Central Government. Currently, six communities are notified as minorities under this section: Muslims, Christians, Sikhs, Buddhists, Parsis, and Jains. A self declaration is a sufficient document to prove the religion of a person.

It is stated in the application that during the academic year 2022-23, out of total 1379 students, 29 students were from the Christian minority community. In the year 2023-24, out of total 1281 students, 28 students were from the Christian minority community.

It has been stated in the physical inspection report submitted by the physical inspection committee that during the academic year 2022-23, out of total 1379 students, 249 students were from the Christian minority community and in the year 2023-24, out of total 1281 students, 233 students were from the Christian minority community

A copy of the physical inspection report be furnished to the learned counsel for the petitioner. Learned counsel for the petitioner is directed to file clarification affidavit in the regard.
