5. Petitioner has also filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

6. It also transpires from the petition that the petitioner Institute is a private unaided university.

7. During the academic year 2022-23, out of 425 students, 05 students were from the Jain minority community, in the year 2023-24, out of total 518 students, 03 students were from the Jain minority community and in the year 2024-25, out of total 876 students, 11 students were from the Jain minority community.

8. It transpires from the petition that the amendment in the Trust Deed is made prior to the filing application u/s 10 of NCMEI Act. 2004 and also petition before this Commission for grant of Minority Status Certificate.
