Notarized copies of relevant documents are already on record i.e., Trust Deed and amended Trust Deed of the Diocese of Thuckalay, Orders of affiliation dated 12.01.2023 and 30.09.2024 issued by the Registrar, Manonmaniam Sundaranar University, Tamil Nadu. Downloaded copy of Unique ID No. TN/2018/0182485 of the petitioner's trust as given by the Niti Aayog Portal NGO Darpan, copy of the application dated 28.03.2022 submitted before the State Competent authority for NOC alongwith postal receipt and its tracking report are also on record. He has filed original resolution of the General Body of the Trust in favour of Mr. Bishop George Rajendran, Managing Trustee of the said Trust, for obtaining MSC from this Commission.

Mr. Bishop George Rajendran, Managing Trustee of the said Trust, and authorized representative of petitioner institution has also filed his affidavit in support of the averments made in the petition and also to prove that the beneficiaries of the petitioner institution are members of the Christian minority community. He has also filed his clarification affidavit regarding numbers of existing teachers/ faculties and students in the petitioner institution and further stated that the petitioner institution shall not deny admission to the eligible candidates of Christian minority community.

As per the information supplied by the unaided petitioner institution with regard to students' strength during the academic year 2020-21, it is mentioned that out of the total 917 students, 02 students were from the Muslim minority community, 685 students were from the Christian minority community and 230 students were Hindu. In the year 2021-22, it is mentioned that out of the total 853 students, 02 students were from the Muslim minority community, 648 students were from the Christian minority community and 203 students were from Hindu. In the year 2022-23, it is mentioned that out of the total 762 students, 03 students were from the Muslim minority community, 597 students were from the Christian minority community and 162 students were Hindu. It is relevant to mention here that during the academic year 2020-21, out of the total 49 teachers, 42 teachers were from the Christian minority community and 07 teachers were Hindu. In the year 2021-22, out of the total 50 teachers, 41 teachers were from the Christian minority community and 09 teachers were Hindu. In the year 2022-23, out of total 52 teachers, 45 teachers were from the Christian minority community and 07 teachers were Hindu.

It is stated in the petition that on dated 28.03.2022, the petitioner institution has applied to the State Competent Authority for grant of NOC which was received by the State Competent Authority on 01.04.2022 and the same is still pending before the State Competent Authority. The State Competent Authority has not granted NOC in favour of the petitioner institution till now and also not rejected the said application and not communicated the same to the petitioner. After 90 days from the receipt of the application for grant of NOC, the petitioner has filed this application for grant of MSC to this Commission straightway as per the provisions of Section 10 and 11(f) of National Commission for Minority Educational Institutions (in short 'NCMEI') Act, 2004.

After service of registered notice/email dated 07.11.2022, no reply/response has been received from the respondent. Thereafter in the facts and circumstances of the case, Commission deemed fit and proper that physical inspection report alongwith recommendation may be obtained from the Committee constituted by this Commission for issuance of MSC to the petitioner institution vide order dated 08.12.2022, after service of letter/ email to the physical inspection committee dated 30.12.2022, 22.03.2023, 30.05.2023, 12.09.2023, 17.11.2023, 27.12.2023, 23.02.2024, 09.05.2024. The District Backward Classes, Kanyakumari, T.N. has sent physical inspection report dated 12.06.2024, which was received in the Commission's Office on dated 16.07.2024 wherein members of the physical inspection committee have recommended the Commission to grant minority status certificate to the petitioner institution.

The petitioner institution has applied for grant of minority status certificate on the ground that the same has been established primarily for the benefit of the members of the Christian minority community and is being administered by the Diocese of Thuckalay, which is managed and run by the members of the Christian minority community. The aforesaid averments made in the petition find ample corroboration from the documentary evidence produced on behalf of the petitioner institution and the affidavit of Mr. Bishop George Rajendran, Managing Trustee of the said Trust, and authorized representative of petitioner institution.

Hon'ble Apex Court, various High Courts as well as this Commission in case of Buckley Primary School, Cuttack, Orissa Vs. Government of Orissa (order passed by this Commission in Case No. 1320 of 2009 dated 06.07.2010) have categorically held that the percentage of admission of students from notified minority community in a minority educational institution is not an indicia for determining the minority status of such institution. This Commission has also decided that there must be reasonable strength of students of particular minority community in a minority educational institution. The percentage could be determined based on the actual proportion of specific minority community in the State population as per prevailing census. Population of Christian minority community in the State of Tamil Nadu as per the census of 2011 is 06.12%.

I have perused the amended Trust Deed of the petitioner trust, which was registered before the Joint Sub Registrar, Marthandam, on dated 07.03.2022, which is before the filing of NOC application U/s 10 of the NCMEI Act, 2004 dated 28.03.2022 and petition for grant of MSC on dated 27.09.2022.

The amended Trust Deed dated 07.03.2022 of the said society and all the documents produced by the petitioner institution clearly reflect that the beneficiaries of the petitioner institution are primarily the members of the Christian minority community. In addition, the said fact also stands proved from the documents and affidavit filed by the petitioner. There is no document on record to rebut the documentary evidence produced on behalf of the petitioner institution before this Commission.

Relying on the said un rebutted evidence produced on behalf of the petitioner, we find and hold that the St. Alphonsa College of Arts and Science, Soosaipuram, Kanyakumari Dt., Tamil Nadu, run by the Diocese of Thuckalay, is eligible for grant of minority status on religious basis. The evidence also proves that the said educational institution was established with the main objective of sub-serving the interests of the Christian minority community.

Consequently, St. Alphonsa College of Arts and Science, Soosaipuram, Kanyakumari Dt., Tamil Nadu, is declared as an unaided minority educational institution covered under Article 30 of the Constitution of India within the meaning of Section 2(g) of the National Commission for Minority Educational Institutions Act, 2004.

A minority status certificate be issued accordingly.

In view of the above, the present petition is disposed of in accordance with this order.
