Learned counsel for the petitioner is heard, perused the pleadings and documents.

Notarized copies of relevant documents are already on record i.e., Certificate of Registration of The Assisi Convent Educational Society, Memorandum of Association, Rules and Regulations alongwith founding members of The Assisi Convent Educational Society, amended Memorandum of Association alongwith list of present members of the said society and downloaded copy of certificate of recognition dated 31.01.2024 issued by the District Basic Education Officer, Agra of petitioner institution are already on record. Downloaded copy of Unique ID No. MH/2017/0152010 of the petitioner's society as given by the Niti Aayog Portal NGO Darpan, copy of the application dated 14.09.2023 submitted before the State Competent authority for NOC alongwith postal receipt and its tracking report are also on record. He has filed original resolution of the General Body of the Society in favour of Stella, President of The Assisi Convent Educational Society, for obtaining MSC from this Commission.

Ms. Stella, President of The Assisi Convent Educational Society, and authorized representative of petitioner institution has also filed her affidavit in support of the averments made in the petition and also to prove that the beneficiaries of the petitioner institution are members of the Christian minority community. She further stated in her affidavit that the petitioner institution shall not deny admission to any eligible students from the Christian minority community, subject to the eligibility of the students and availability of accommodation.

As per the information supplied by the unaided petitioner institution with regard to students' strength during the academic year 2021-22, it is mentioned that out of the total 92 students, 05 students were from the Muslim minority community, 02 students were from the Christian minority community, 01 student was from Jain minority community and 84 students were Hindu. In the year 2022-23, it is mentioned that out of the total 133 students, 06 students were from the Muslim minority community, 03 students were from the Christian minority community, 01 student was from the Jain minority community and 123 students were Hindu. In the year 2023-24, it is mentioned that out of the total 161 students, 06 students were from the Muslim minority community, 03 students were from the Christian minority community, 03 students were from the Jain

minority community and 149 students were Hindu. It is relevant to mention here that during the academic year 2021-22, out of the total 09 teachers, 07 teachers were from Christian minority community and 02 teachers were Hindu. In the year 2022-23, out of the total 11 teachers, 01 teacher were from Muslim minority community, 08 teachers were from the Christian minority community and 02 teachers were Hindu. In the year 2023-24, out of total 13 teachers, 01 teacher was from the Muslim minority community, 09 teachers were from the Christian minority community and 03 teachers were Hindu.

It is stated in the petition that on dated 14.09.2023, the petitioner institution has applied to the State Competent Authority for grant of NOC which was received by the State Competent Authority on 18.09.2023 and the same is still pending before the State Competent Authority. The State Competent Authority has not granted NOC in favour of the petitioner institution till now and also not rejected the said application and not communicated the same to the petitioner. After 90 days from the receipt of the application for grant of NOC, the petitioner has filed this application for grant of MSC to this Commission straightway as per the provisions of Section 10 and 11(f) of National Commission for Minority Educational Institutions (in short 'NCMEI') Act, 2004.

After service of registered notice/email dated 20.02.2024, no reply/response has been received from the respondent. Thereafter in the facts and circumstances of the case, Commission deemed fit and proper that physical inspection report alongwith recommendation may be obtained from the Committee constituted by this Commission for issuance of MSC to the petitioner institution vide order dated 01.05.2024, after service of letter/ email to the physical inspection committee dated 18.06.2024 and 06.09.2024, 04.11.2024 and 29.01.2025, the District Magistrate, Agra, has sent physical inspection report dated 28.02.2025, which was received in the Commission's Office on dated 05.03.2025 wherein they have not given any adverse remarks.

The petitioner institution has applied for grant of minority status certificate on the ground that the same has been established primarily for the benefit of the members of the Christian minority community and is being administered by The Assisi Convent Educational Society, which is managed and run by the members of the Christian minority community. The aforesaid averments made in the petition find ample corroboration from the documentary evidence produced on behalf of the petitioner institution and the affidavit of Ms. Stella, President of The Assisi Convent Educational Society, and authorized representative of petitioner institution.

Hon'ble Apex Court, various High Courts as well as this Commission in case of Buckley Primary School, Cuttack, Orissa Vs. Government of Orissa (order passed by this Commission in Case No. 1320 of 2009 dated 06.07.2010) have categorically held that the percentage of admission of students from notified minority community in a minority educational institution is not an indicia for determining the minority status of such institution. This Commission has also decided that there must be reasonable strength of students of particular minority community in a minority educational institution. The percentage could be determined based on the actual proportion of specific minority community in the State population as per prevailing census. Population of Christian minority community in the State of Uttar Pradesh as per the census of 2011 is 0.18%.

I have perused the amended Memorandum of Association of the petitioner institution, which was registered before the Principal Assistant, Firms, Societies and Chits, Uttar Pradesh, on dated 18.11.2022 which is before the filing of NOC application U/s 10 of the NCMEI Act, 2004 dated 14.09.2023 and petition for grant of MSC on dated 06.02.2024.

The amended Memorandum of Association dated 18.11.2022 of the said society and all the documents produced by the petitioner institution clearly reflect that the beneficiaries of the petitioner institution are primarily the members of the Christian minority community. In addition, the said fact also stands proved from the documents and affidavit filed by the petitioner. There is no document on record to rebut the documentary evidence produced on behalf of the petitioner institution before this Commission.

Relying on the said un rebutted evidence produced on behalf of the petitioner, we find and hold that the Assisi Convent School, Nanpur, Jaipur Road, Agra, U.P., run by The Assisi Convent Educational Society, is eligible for grant of minority status on religious basis. The evidence also proves that the said educational institution was established with the main objective of sub-serving the interests of the Christian minority community.

Consequently, Assisi Convent School, Nanpur, Jaipur Road, Agra, U.P., is declared as unaided minority educational institution covered under Article 30 of the Constitution of India within the meaning of Section 2(g) of the National Commission for Minority Educational Institutions Act, 2004.

A minority status certificate be issued accordingly.

In view of the above, the present petition is disposed of in accordance with this order.

Notarized copies of relevant documents are already on record i.e., Certificate of Registration of The Assisi Convent Educational Society, Memorandum of Association, Rules and Regulations alongwith founding members of The Assisi Convent Educational Society, amended Memorandum of Association alongwith list of present members of the said society and downloaded copy of certificate of recognition dated 31.01.2024 issued by the District Basic Education Officer, Agra of petitioner institution are already on record. Downloaded copy of Unique ID No. MH/2017/0152010 of the petitioner's society as given by the Niti Aayog Portal NGO Darpan, copy of the application dated 14.09.2023 submitted before the State Competent authority for NOC alongwith postal receipt and its tracking report are also on record. He has filed original resolution of the General Body of the Society in favour of Stella, President of The Assisi Convent Educational Society, for obtaining MSC from this Commission.

Ms. Stella, President of The Assisi Convent Educational Society, and authorized representative of petitioner institution has also filed her affidavit in support of the averments made in the petition and also to prove that the beneficiaries of the petitioner institution are members of the Christian minority community. She further stated in her affidavit that the petitioner institution shall not deny admission to any eligible students from the Christian minority community, subject to the eligibility of the students and availability of accommodation.

As per the information supplied by the unaided petitioner institution with regard to students' strength during the academic year 2021-22, it is mentioned that out of the total 651 students, 26 students were from the Muslim minority community, 16 students were from the Christian minority community, 02 students were from Sikh minority community and 607 students were Hindu. In the year 2022-23, it is mentioned that out of the total 598 students, 34 students were from the Muslim minority community, 13 students were from the Christian minority community, 02 students were from the Sikh minority community and 549 students were Hindu. In the year 2023-24, it is mentioned that out of the total 582 students, 33 students were from the Muslim minority community, 12 students were from the Christian minority community, 02 students were from the Sikh

minority community and 535 students were Hindu. It is relevant to mention here that during the academic year 2021-22, out of the total 28 teachers, 09 teachers were from Christian minority community and 19 teachers were Hindu. In the year 2022-23, out of the total 28 teachers, 11 teachers were from Christian minority community and 17 teachers were Hindu. In the year 2023-24, out of total 28 teachers, 11 teachers were from the Christian minority community and 17 teachers were Hindu.

It is stated in the petition that on dated 14.09.2023, the petitioner institution has applied to the State Competent Authority for grant of NOC which was received by the State Competent Authority on 18.09.2023 and the same is still pending before the State Competent Authority. The State Competent Authority has not granted NOC in favour of the petitioner institution till now and also not rejected the said application and not communicated the same to the petitioner. After 90 days from the receipt of the application for grant of NOC, the petitioner has filed this application for grant of MSC to this Commission straightway as per the provisions of Section 10 and 11(f) of National Commission for Minority Educational Institutions (in short 'NCMEI') Act, 2004.

After service of registered notice/email dated 20.02.2024, no reply/response has been received from the respondent. Thereafter in the facts and circumstances of the case, Commission deemed fit and proper that physical inspection report alongwith recommendation may be obtained from the Committee constituted by this Commission for issuance of MSC to the petitioner institution vide order dated 01.05.2024, after service of letter/ email to the physical inspection committee dated 18.06.2024 and 03.09.2024, 29.10.2024, 30.10.2025 and 27.01.2025, the District Magistrate, Gautam Budh Nagar, has sent physical inspection report dated 13.01.2025, which was received in the Commission's Office on dated 21.01.2025 wherein they have not given any adverse remarks.

The petitioner institution has applied for grant of minority status certificate on the ground that the same has been established primarily for the benefit of the members of the Christian minority community and is being administered by The Assisi Convent Educational Society, which is managed and run by the members of the Christian minority community. The aforesaid averments made in the petition find ample corroboration from the documentary evidence produced on behalf of the petitioner institution and the affidavit of Ms. Stella, President of The Assisi Convent Educational Society, and authorized representative of petitioner institution.

Hon'ble Apex Court, various High Courts as well as this Commission in case of Buckley Primary School, Cuttack, Orissa Vs. Government of Orissa (order passed by this Commission in Case No. 1320 of 2009 dated 06.07.2010) have categorically held that the percentage of admission of students from notified minority community in a minority educational institution is not an indicia for determining the minority status of such institution. This Commission has also decided that there must be reasonable strength of students of particular minority community in a minority educational institution. The percentage could be determined based on the actual proportion of specific minority community in the State population as per prevailing census. Population of Christian minority community in the State of Uttar Pradesh as per the census of 2011 is 0.18%.

I have perused the amended Memorandum of Association of the petitioner institution, which was registered before the Principal Assistant, Firms, Societies and Chits, Uttar Pradesh, on dated 18.11.2022 which is before the filing of NOC application U/s 10 of the NCMEI Act, 2004 dated 14.09.2023 and petition for grant of MSC on dated 06.02.2024.

The amended Memorandum of Association dated 18.11.2022 of the said society and all the documents produced by the petitioner institution clearly reflect that the beneficiaries of the petitioner institution are primarily the members of the Christian minority community. In addition, the said fact also stands proved from the documents and affidavit filed by the petitioner. There is no document on record to rebut the documentary evidence produced on behalf of the petitioner institution before this Commission.

Relying on the said un rebutted evidence produced on behalf of the petitioner, we find and hold that the Assisi Convent Primary School, B.H.E.L. Colony, Sector 17, Noida, U.P., run by The Assisi Convent Educational Society, is eligible for grant of minority status on religious basis. The evidence also proves that the said educational institution was established with the main objective of sub-serving the interests of the Christian minority community.

Consequently, Assisi Convent Primary School, B.H.E.L. Colony, Sector 17, Noida, U.P., is declared as unaided minority educational institution covered under Article 30 of the Constitution of India within the meaning of Section 2(g) of the National Commission for Minority Educational Institutions Act, 2004.

A minority status certificate be issued accordingly.

In view of the above, the present petition is disposed of in accordance with this order.
