Notarized copies of relevant documents are already on record i.e., Certificate of Registration and Renewed Certificate of Registration dated 21.01.2025 of the Al Raza Memorial Society, Memorandum of Association, Rules and Regulations alongwith founding members of the Al Raza Memorial Society, amended Memorandum of Association alongwith list of present members of the said society and recognition order dated 01.07.2013 issued by the District Basic Education Officer, Azamgarh of petitioner institution are already on record. Downloaded copy of Unique ID No. UP/2023/0360185 of the petitioner's society as given by the Niti Aayog Portal NGO Darpan, copy of the application dated 12.05.2023 submitted before the State Competent authority for NOC alongwith postal receipt and its tracking report are also on record. He has filed original resolution of the General Body of the Society in favour of Mr. Abdul Wahab Khan, Manager of Al Raza Memorial Society, for obtaining MSC from this Commission.

Mr. Abdul Wahab Khan, Manager of Al Raza Memorial Society, and authorized representative of petitioner institution has also filed his affidavit in support of the averments made in the petition and also to prove that the beneficiaries of the petitioner institution are members of the Muslim minority community.

As per the information supplied by the unaided petitioner institution with regard to students' strength during the academic year 2020-21, it is mentioned that out of the total 376 students, 324 students were from the Muslim minority community and 52 students were Hindu. In the year 2021-22, it is mentioned that out of the total 359 students, 334 students were from the Muslim minority community and 25 students were Hindu. In the year 2022-23, it is mentioned that out of the total 327 students, 292 students were from the Muslim minority community and 35 students were Hindu. It is relevant to mention here that during the academic year 2020-21, out of the total 11 teachers, 08 teachers were from Muslim minority community and 03 teachers were Hindu. In the year 2021-22, out of the total 11 teachers, 06 teachers were from Muslim minority community and 05 teachers were Hindu. In the year 2022-23, out of total 11 teachers, 08 teachers were from the Muslim minority community and 03 teachers were Hindu.

It is stated in the petition that on dated 12.05.2023, the petitioner institution has applied to the State Competent Authority for grant of NOC which was received by the State Competent Authority on 17.05.2023 and the same is still pending before the State Competent Authority. The State Competent Authority has not granted NOC in favour of the petitioner institution till now and also not rejected the said application and not communicated the same to the petitioner. After 90 days from the receipt of the application for grant of NOC, the petitioner has filed this application for grant of MSC to this Commission straightway as per the provisions of Section 10 and 11(f) of National Commission for Minority Educational Institutions (in short 'NCMEI') Act, 2004.

After service of registered notice/email dated 03.01.2024, no reply/response has been received from the respondent. Thereafter in the facts and circumstances of the case, Commission deemed fit and proper that physical inspection report alongwith recommendation may be obtained from the Committee constituted by this Commission for issuance of MSC to the petitioner institution vide order dated 14.02.2024, after service of letter/ email to the physical inspection committee dated 19.02.2024 and 27.06.2024, 06.09.2024, 04.11.2024 and 28.01.2025, the District Minority Welfare Officer, Azamgarh, has sent physical inspection report dated 03.02.2025, which was received in the Commission's Office on dated 11.02.2025 wherein they mentioned that the petitioner institution is recognized by the education sector in Palhani and it is in the city area. They have not given any adverse remarks.

The petitioner institution has applied for grant of minority status certificate on the ground that the same has been established primarily for the benefit of the members of the Muslim minority community and is being administered by the Al Raza Memorial Society, which is managed and run by the members of the Muslim minority community. The aforesaid averments made in the petition find ample corroboration from the documentary evidence produced on behalf of the petitioner institution and the affidavit of Mr. Abdul Wahab Khan, Manager of Al Raza Memorial Society and authorized representative of petitioner institution.

Hon'ble Apex Court, various High Courts as well as this Commission in case of Buckley Primary School, Cuttack, Orissa Vs. Government of Orissa (order passed by this Commission in Case No. 1320 of 2009 dated 06.07.2010) have categorically held that the percentage of admission of students from notified minority community in a minority educational institution is not an indicia for determining the minority status of such institution. This Commission has also decided that there must be reasonable strength of students of particular minority community in a minority educational institution. The percentage could be determined based on the actual proportion of specific minority community in the State population as per prevailing census. Population of Muslim minority community in the State of Uttar Pradesh as per the census of 2011 is 19.26%.

I have perused the amended Memorandum of Association of the petitioner institution, which was registered before the Deputy Registrar (Societies), Azamgarh Mandal, Azamgarh, Uttar Pradesh, on dated 01.02.2023 which is before the filing of NOC application U/s 10 of the NCMEI Act, 2004 dated 12.05.2023 and petition for grant of MSC on dated 20.10.2023.

The amended Memorandum of Association dated 01.02.2023 of the said society and all the documents produced by the petitioner institution clearly reflect that the beneficiaries of the petitioner institution are primarily the members of the Muslim minority community. In addition, the said fact also stands proved from the documents and affidavit filed by the petitioner. There is no document on record to rebut the documentary evidence produced on behalf of the petitioner institution before this Commission.

Relying on the said un rebutted evidence produced on behalf of the petitioner, we find and hold that the City Public School, Dharmunala, Palhani, Azamgarh, U.P., run by the Al Raza Memorial Society, is eligible for grant of minority status on religious basis. The evidence also proves that the said educational institution was established with the main objective of sub-serving the interests of the Muslim minority community.

Consequently, City Public School, Dharmunala, Palhani, Azamgarh, U.P., is declared as unaided minority educational institution covered under Article 30 of the Constitution of India within the meaning of Section 2(g) of the National Commission for Minority Educational Institutions Act, 2004 subject to the condition that the petitioner would file an affidavit or undertaking to the fact that the petitioner institution shall not deny admission of eligible candidate of the Muslim minority community subject to the eligibility of the students and availability of the accommodation in the petitioner institution. If the petitioner institution failed to comply the above order of this Commission within a period of three months from the date of order passed by this Commission then the petition filed by the petitioner for grant of MSC will be automatically deemed to be dismissed.

After compliance of the above order, a minority status certificate be issued accordingly.

In view of the above, the present petition is disposed of in accordance with this order.

Additional Deputy Commissioner (G), Ferozepur vide letter dated 22.3.2025 has sent detailed report, which was received by post before the Commission's office on 4.4.2025. The same is also taken on record. The said report is not in the proper format prescribed by the Commission.

It is mentioned in the letter that the school has a total of 355 students, out of which the school has given a list of 41 students. During the investigation, it was found that only 4 students were found to be named Christian. As per the application submitted by the petitioner institution, during the academic year 2023-24, out of total 343 students, 41 students were from the Christian minority community.

Section 2(c) of the National Commission for Minorities Act, 1992 defines a "Minority" as a community notified as such by the Central Government. Currently, six communities are notified as minorities under this section: Muslims, Christians, Sikhs, Buddhists, Parsis, and Jains. A self declaration is a sufficient document to prove the religion of a person.

Office is directed to send reminder letter to the members of the physical inspection committee for sending the original physical inspection report duly signed by all the members of the committee before the next date of hearing.

Office is also directed to write a letter to the members of the physical inspection committee intimating them that a self declaration is a sufficient document to prove the religion of a person. Copy of both the letter be furnished to the learned counsel for the petitioner for pursuing the matter with the members of the physical inspection committee and also apprise them about the format issued by the Ministry of Minority Affairs regarding self-declaration of minority community by students.
