Learned counsel for the petitioner is heard, perused the pleadings and documents.

Notarized copies of relevant documents are already on record i.e., Certificate of Registration, Memorandum of Association, Rules and Regulations alongwith founding members of the Anjuman Makhdoomiyan Sirajul Uloom, list of present members of the said society and certificate of permanent recognition dated 08.08.2011 issued by the Uttar Pradesh Madarsa Shiksha Parishad, Lucknow and certificate of recognition issued by the Registrar, Arbi & Farsi Examinations, Lucknow, U.P., of petitioner institution are already on record. Notarized downloaded copy of Unique ID No. UP/2019/0236718 of the petitioner's society as given by the Niti Aayog Portal NGO Darpan, copy of the application dated 20.10.2021 submitted before the State Competent authority for NOC alongwith postal receipt and its tracking report are also on record. He has filed original resolution of the General Body of the Society in favour of Mr. Laiq Ahmad, Secretary of the Anjuman Makhdoomiyan Sirajul Uloom, for obtaining MSC from this Commission.

Mr. Laiq Ahmad, Secretary of the Anjuman Makhdoomiyan Sirajul Uloom, and authorized representative of petitioner institution has also filed his affidavit in support of the averments made in the petition and also to prove that the beneficiaries of the petitioner institution are members of the Muslim minority community.

As per the information supplied by the aided petitioner institution with regard to students' strength during the academic year 2020-21, it is mentioned that out of the total 488 students, all students were from the Muslim minority community. In the year 2021-22, it is mentioned that out of the total 523 students, all students were from the Muslim minority community. In the year 2022-23, it is mentioned that out of the total 679 students, all students were from the Muslim minority community. It is relevant to mention here that during the academic year 2020-21, out of the total 22 teachers, all teachers were from Muslim minority community. In the year 2021-22, out of the total 24 teachers, all teachers were from Muslim minority community. In the year 2022-

23, out of total 26 teachers, all teachers were from the Muslim minority community.

It is stated in the petition that on dated 20.10.2021, the petitioner institution has applied to the State Competent Authority for grant of NOC which was received by the State Competent Authority on 25.10.2021 and the same is still pending before the State Competent Authority. The State Competent Authority has not granted NOC in favour of the petitioner institution till now and also not rejected the said application and not communicated the same to the petitioner. After 90 days from the receipt of the application for grant of NOC, the petitioner has filed this application for grant of MSC to this Commission straightway as per the provisions of Section 10 and 11(f) of National Commission for Minority Educational Institutions (in short 'NCMEI') Act, 2004.

After service of registered notice/email dated 22.12.2022, no reply/ response has been received from the respondent. Thereafter in the facts and circumstances of the case, Commission deemed fit and proper that physical inspection report alongwith recommendation may be obtained from the Committee constituted by this Commission for issuance of MSC to the petitioner institution vide order dated 22.02.2023, after service of letter/ email to the physical inspection committee dated 27.02.2023, 27.07.2023, 28.08.2023, 22.11.2023, 28.12.2023, 28.02.2024, 09.04.2024, 24.07.2024 and 11.07.2024.

On 21.01.2025 this case was listed for pronouncement but it was observed that it is stated against column no. 11 of the physical inspection report that the petitioner institution is an aided institution whereas it is mentioned as unaided in the application format of minority status certificate filed by the petitioner institution. Learned counsel for the petitioner prayed for time to file clarification affidavit in this regard. On 28.01.2025 clarification affidavit was received from the learned counsel for the petitioner mentioning therein that due to inadvertence a typographical error has crept in the column no. 11 of the said application format. Thereafter, on 20.05.2025, learned counsel for the petitioner filed amended petition by filing an application under section VI Rule 17 CPC read with Section 12(2) of the NCMEI Act, 2004. Subsequently, a notice was issued to the respondent on 27.05.2025, again no reply/ response received on behalf of the respondent. The District Minority Welfare Officer, Kanpur, has sent physical inspection report dated 16.07.2024, which was received in the Commission's Office on dated 24.07.2024 wherein members of the physical inspection committee have recommended the Commission to grant minority status certificate to the petitioner institution.

The petitioner institution has applied for grant of minority status certificate on the ground that the same has been established primarily for the benefit of the members of the Muslim minority community and is being administered by the Anjuman Makhdoomiyani Sirajul Uloom, which is managed and run by the members of the Muslim minority community. The aforesaid averments made in the petition find ample corroboration from the documentary evidence produced on behalf of the petitioner institution and the affidavit of Mr. Laiq Ahmad, Secretary of the Anjuman Makhdoomiyani Sirajul Uloom, and authorized representative.

Hon'ble Apex Court, various High Courts as well as this Commission in case of Buckley Primary School, Cuttack, Orissa Vs. Government of Orissa (order passed by this Commission in Case No. 1320 of 2009 dated 06.07.2010) have categorically held that the percentage of admission of students from notified minority community in a minority educational institution is not an indicia for determining the minority status of such institution. This Commission has also decided that there must be reasonable strength of students of particular minority community in a minority educational institution. The percentage could

be determined based on the actual proportion of specific minority community in the State population as per prevailing census. Population of Muslim minority community in the State of Uttar Pradesh as per the census of 2011 is 19.26%.

I have perused the Memorandum of Association of the petitioner institution, which was registered before the Registrar Firms, Societies & Chits, Kanpur, Uttar Pradesh, on dated 25.11.1997, which is before the filing of NOC application U/s 10 of the NCMEI Act, 2004 dated 20.10.2021 and petition for grant of MSC on dated 20.10.2023.

The Memorandum of Association dated 25.11.1997 of the said society and all the documents produced by the petitioner institution clearly reflect that the beneficiaries of the petitioner institution are primarily the members of the Muslim minority community. In addition, the said fact also stands proved from the documents and affidavit filed by the petitioner. There is no document on record to rebut the documentary evidence produced on behalf of the petitioner institution before this Commission.

Relying on the said un rebutted evidence produced on behalf of the petitioner, we find and hold that the Madrasa Makhdoomiya Sirajul Uloom, Jajmau, Kanpur, U.P., run by the Anjuman Makhdoomiyah Sirajul Uloom, is eligible for grant of minority status on religious basis. The evidence also proves that the said educational institution was established with the main objective of sub-serving the interests of the Muslim minority community.

Consequently, Madrasa Makhdoomiya Sirajul Uloom, Jajmau, Kanpur, U.P., is declared as an aided minority educational institution covered under Article 30 of the Constitution of India within the meaning of Section 2(g) of the National Commission for Minority Educational Institutions Act, 2004 subject to the condition that the petitioner would file an affidavit or undertaking to the fact that the petitioner institution shall not deny admission of eligible candidate of the Muslim minority community subject to the eligibility of the students and availability of the accommodation in the petitioner institution. If the petitioner institution failed to comply the above order of this Commission within a period of three months from the date of order passed by this Commission then the petition filed by the petitioner for grant of MSC will be automatically deemed to be dismissed.

After compliance of the above order, a minority status certificate be issued accordingly.

In view of the above, the present petition is disposed of in accordance with this order.
