Learned counsel for the petitioner is heard, perused the pleadings and documents.

Certified copies of relevant documents are already on record i.e., Certificate of Registration, Memorandum of Association, Rules and Regulations alongwith founding members, amended Memorandum of Association alongwith present members list of the Guru Nanak Educational Society. Notarized copies of latest Certificate of Registration of the said society and Order of recognition dated 12.06.1996 issued by the Assistant Education Officer (Basic), Faizabad Mandal, order dated 21.12.2002, issued by the District Basic Education Officer, Faizabad and order dated 26.12.2006 issued by the Regional Secretary, Madhyamik Shiksha Parishad, Varanasi. Downloaded copy of Unique ID No. UP/2017/0153310 of the petitioner's society as given by the Niti Aayog Portal NGO Darpan. Copy of the application dated 30.01.2020 submitted before the State Competent authority for NOC alongwith postal receipt and its tracking report are also on record. He has filed original resolution of the General Body of the said Society in favour of Mr. Rajendra Singh Chhabra, President of the said Society, for obtaining MSC from this Commission.

Mr. Rajendra Singh Chhabra, President of the said Society, and authorized representative of petitioner institution has also filed his affidavit in support of the averments made in the petition and also to prove that the beneficiaries of the petitioner institution are members of the Sikh minority community. He has also filed clarification affidavit regarding difference in the information supplied by the petitioner and the data submitted by the physical inspection committee of total number of students and number of Sikh students of the petitioner institution. He has clarified that the information submitted by the petitioner as on 01.01.2020 is prior to covid period and the data submitted by the physical inspection committee is post covid. He further stated that the petitioner institution shall not deny admission to the eligible candidates of Sikh minority community.

As per the information supplied by the unaided petitioner institution with regard to students' strength as on 01.01.2020, it is mentioned that out of the total 765 students, 169 students were from the Muslim minority community, 18 students were from the Christian minority community, 219 students were from the Sikh minority community, 48 students were from the Jain minority community, 06 students were from the Parsee minority community and 305 students were Hindu. It is relevant to mention here that as on 01.01.2020, out of the total 44 teachers, 13 teachers were from the Muslim minority community, 02 teachers were from the Christian minority community, 19 teachers were from the Sikh minority community, 06 teachers were from the Parsee minority community and 04 teachers were Hindu.

It is stated in the petition that on dated 30.01.2020, the petitioner institution has applied to the State Competent Authority for grant of NOC which was received by the State Competent Authority on 03.02.2020 and the same is still pending before the State Competent Authority. The State Competent Authority has not granted NOC in favour of the petitioner institution till now and also not rejected the said application and not communicated the same to the petitioner. After 90 days from the receipt of the application for grant of NOC, the petitioner has filed this application for grant of MSC to this Commission straightway as per the provisions of Section 10 and 11(f) of National Commission for Minority Educational Institutions (in short 'NCMEI') Act, 2004.

After service of registered notice/email dated 11.04.2022 and 30.08.2022, no reply/ response has been received from the respondent. Thereafter in the facts and circumstances of the case, Commission deemed fit and proper that physical inspection report alongwith recommendation may be obtained from the Committee constituted by this Commission for issuance of MSC to the petitioner institution vide order dated 27.09.2022, after service of letter/ email to the physical inspection committee dated 20.10.2022, 23.11.2022, 05.01.2023, 13.03.2023, 03.05.2023, 02.08.2023, 12.10.2023, 15.12.2023, 20.02.2024, 21.05.2024 and 27.08.2024. The District Minority Welfare Officer, Ayodhya, has sent physical inspection report dated 06.09.2024, which was received in the Commission's Office on dated 12.09.2024 wherein members of the physical inspection committee have not recommended the Commission to grant minority status certificate to the petitioner institution but has not given any adverse remarks. As per physical inspection report, during the academic year 2024-25, out of 731 students, 16 students were from the Sikh minority community, which is 2.18%, which is more than the State census of 2011 i.e. 0.32%.

The petitioner institution has applied for grant of minority status certificate on the ground that the same has been established primarily for the benefit of the members of the Sikh minority community and is being administered by the Guru Nanak Educational Society, which is managed and run by the members of the Sikh minority community. The aforesaid averments made in the petition find ample corroboration from the documentary evidence produced on behalf of the petitioner institution and the affidavit of Mr. Rajendra Singh Chhabra, President of the said Society, and authorized representative of petitioner institution.

Hon'ble Apex Court, various High Courts as well as this Commission in case of Buckley Primary School, Cuttack, Orissa Vs. Government of Orissa (order passed by this Commission in Case No. 1320 of 2009 dated 06.07.2010) have categorically held that the percentage of admission of students from notified minority community in a minority educational institution is not an indicia for determining the minority status of such institution. This Commission has also

decided that there must be reasonable strength of students of particular minority community in a minority educational institution. The percentage could be determined based on the actual proportion of specific minority community in the State population as per prevailing census. Population of Sikh minority community in the State of Uttar Pradesh as per the census of 2011 is 0.32%.

I have perused the amended Memorandum of Association dated 20.11.2016 of the petitioner society, which was certified by the Deputy Registrar, Firms, Societies and Chits, Faizabad, U.P., on dated 28.01.2017, which is before the filing of NOC application U/s 10 of the NCMEI Act, 2004 dated 30.01.2020 and petition for grant of MSC on dated 28.09.2020.

The amended Memorandum of Association of the said Society dated 20.11.2016 of the said society and all the documents produced by the petitioner institution clearly reflect that the beneficiaries of the petitioner institution are primarily the members of the Sikh minority community. In addition, the said fact also stands proved from the documents and affidavit filed by the petitioner. There is no document on record to rebut the documentary evidence produced on behalf of the petitioner institution before this Commission.

Relying on the said unrebutted evidence produced on behalf of the petitioner, we find and hold that the Guru Nanak Girls High School, Khirki Ali Beg, Faizabad, U.P., run by the Guru Nanak Educational Society, is eligible for grant of minority status on religious basis. The evidence also proves that the said educational institution was established with the main objective of sub-serving the interests of the Sikh minority community.

Consequently, Guru Nanak Girls High School, Khirki Ali Beg, Faizabad, U.P., is declared as an unaided minority educational institution covered under Article 30 of the Constitution of India within the meaning of Section 2(g) of the National Commission for Minority Educational Institutions Act, 2004.

A minority status certificate be issued accordingly.

In view of the above, the present petition is disposed of in accordance with this order.

Learned counsel for the petitioner is heard, perused the pleadings and documents.

Notarized copies of relevant documents are already on record i.e., Certificate of Registration, Memorandum of Association, Rules and Regulations alongwith founding members, amended Memorandum of Association alongwith present members list of the Diocese of Varanasi Education Society. Notarized copy of Certificate of Affiliation of the petitioner institution issued by the ICSE. Downloaded copy of Unique ID No. UP/2017/0169218 of the petitioner's society as given by the Niti Aayog Portal NGO Darpan. Copy of the application dated 21.10.2023 submitted before the State Competent authority for NOC alongwith postal receipt and its tracking report are also on record. He has filed original resolution of the General Body of the said Society in favour of Fr. Thomas Mathew, Secretary of the said Society, for obtaining MSC from this Commission.

Fr. Thomas Mathew, Secretary of the said Society, and authorized representative of petitioner institution has also filed his affidavit in support of the averments made in the petition and also to prove that the beneficiaries of the petitioner institution are members of the Christian minority community.

As per the information supplied by the unaided petitioner institution with regard to students' strength during the academic year 2021-22 out of the total 256 students, 13 students were from the Muslim minority community, 06 students were from the Christian minority community and 237 students were Hindu. During the academic year 2022-23, out of the total 270 students, 13 students were from the Muslim minority community, 06 students were from the Christian minority community and 251 students were Hindu. In the academic year 2023-24, it is mentioned that out of the total 348 students, 23 students were from the Muslim minority community, 08 students were from the Christian minority community and 317 students were Hindu. It is relevant to mention here that in the academic year 2021-22, out of the total 15 teachers, 06 teachers were from the Christian minority community and 09 teachers were Hindu. In the academic year 2022-23, out of the total 15 teachers 06 teachers were from the Christian minority community and 09 teachers were Hindu. During the academic year out of the total 15 teachers 06 teachers were Christian and 10 teachers were Hindu.

It is stated in the petition that on dated 21.10.2023, the petitioner institution has applied to the State Competent Authority for grant of NOC which was received by the State Competent Authority on 02.11.2023 and the same is still pending before the State Competent Authority. The State Competent Authority has not granted NOC in favour of the petitioner institution till now and also not rejected the said application and not communicated the same to the petitioner. After 90 days from the receipt of the application for grant of NOC, the petitioner has filed this application for grant of MSC to this Commission straightway as per the provisions of Section 10 and 11(f) of National Commission for Minority Educational Institutions (in short 'NCMEI') Act, 2004.

After service of registered notice/email dated 06.05.2024, no reply/ response has been received from the respondent. Thereafter in the facts and circumstances of the case, Commission deemed fit and proper that physical inspection report alongwith recommendation may be obtained from the Committee constituted by this Commission for issuance of MSC to the petitioner institution vide order dated 16.07.2024, after service of letter/ email to the physical inspection committee dated 12.08.2024, 08.10.2024, 13.12.2024 and 03.03.2025. The District Magistrate, Bhadohi, has sent physical inspection report dated 17.04.2025, which was received in the Commission's Office on dated 28.04.2025 wherein members of the physical inspection committee have not recommended the Commission to grant minority status certificate to the petitioner institution but has not given any adverse remarks. As per physical inspection report, during the academic year 2025-26, out of 453 students, 11 students are from the Christian minority community, which is 2.42%, which is more than the State census of 2011 i.e. 0.18%.

The petitioner institution has applied for grant of minority status certificate on the ground that the same has been established primarily for the benefit of the members of the Christian minority community and is being administered by the Diocese of Varanasi Education Society, which is managed and run by the members of the Christian minority community. The aforesaid averments made in the petition find ample corroboration from the documentary evidence produced on behalf of the petitioner institution and the affidavit of Fr. Thomas Mathew, Secretary of the said Society, and authorized representative of petitioner institution.

Hon'ble Apex Court, various High Courts as well as this Commission in case of Buckley Primary School, Cuttack, Orissa Vs. Government of Orissa (order passed by this Commission in Case No. 1320 of 2009 dated 06.07.2010) have categorically held that the percentage of admission of students from notified minority community in a minority educational institution is not an indicia for determining the minority status of such institution. This Commission has also decided that there must be reasonable strength of students of particular minority community in a minority educational institution. The percentage could be determined based on the actual proportion of specific minority community in the State population as per prevailing census. Population of Christian minority community in the State of Uttar Pradesh as per the census of 2011 is 0.18%.

I have perused the notarized amended Memorandum of Association of the petitioner society, which was certified by the Assistant Registrar, Firms, Societies Evam Chits, Varanasi, on dated 07.01.2010, which is before the filing of NOC application U/s 10 of the NCMEI Act, 2004 dated 21.10.2023 and petition for grant of MSC on dated 12.03.2024.

The aforesaid amended Memorandum of Association of the said Society and all the documents produced by the petitioner institution clearly reflect that the beneficiaries of the petitioner institution are primarily the members of the Christian minority community. In addition, the said fact also stands proved from the documents and affidavit filed by the petitioner. There is no document on record to rebut the documentary evidence produced on behalf of the petitioner institution before this Commission.

Relying on the said un rebutted evidence produced on behalf of the petitioner, we find and hold that the St. John's School, Pachwal, Babhanauti, Sant Ravidas Nagar, Bhadohi, U.P., run by the Diocese of Varanasi Education Society, is eligible for grant of minority status on religious basis. The evidence also proves that the said educational institution was established with the main objective of subserving the interests of the Christian minority community.

Consequently, St. John's School, Pachwal, Babhanauti, Sant Ravidas Nagar, Bhadohi, U.P., is declared as an unaided minority educational institution covered under Article 30 of the Constitution of India within the meaning of Section 2(g) of the National Commission for Minority Educational Institutions Act, 2004 subject to the condition that the petitioner would file an affidavit or undertaking to the fact that the petitioner institution shall not deny admission of eligible candidate of the Christian minority community subject to the eligibility of the students and availability of the accommodation in the petitioner institution. If the petitioner institution failed to comply the above order of this Commission within a period of three months from the date of order passed by this Commission then the petition filed by the petitioner for grant of MSC will be automatically deemed to be dismissed.

After compliance of the above order, a minority status certificate be issued accordingly.

In view of the above, the present petition is disposed of in accordance with this order.
