## <u>ORDER</u>

- 1. This petition has been received on 28.02.2025 by post through Mr. Iftekhar Ahmed, Advocate of the petitioner institution for grant of Minority Status Certificate (in short 'MSC') to City Public College of Education, Plot No. 40 MIN2, Street No. Shadhora, Village- Muhal Dhehar, Post Shadhora, District Ashok Nagar, Madhya Pradesh 473330.
- 2. Learned counsel for the petitioner filedan affidavit of Mr. Anwar Shah, President of Rudra Educational Institute Samitiin support of the averments made in the petition and also to prove that the beneficiaries of the petitioner institution are members of the Muslimminority. He has also filed affidavit stating therein that the petitioner institution shall not deny admission of eligible candidate of the Muslim minority community subject to the eligibility of the students and availability of the accommodation in the petitioner institution.
- 3. Learned counsel for the petitioner has filed copy of Unique ID No.: MP/2023/0376613of the petitioner's Society as given by the Niti Aayog Portal NGO Darpan, original copy of application dated 13.08.2024by hand to the State Competent Authority, notarized copy of Certificate of Registration of Rudra Educational Institute Samiti,certified copy of Memorandum of Association alongwith founding member list of society,certified copy of rules and regulations of the society,certified copy of list of present members of the Society,notarized copy of affiliation dated 20.06.2016 issued by the Regional Director, NCTE granting affiliation to the unaided petitioner institutionand original resolution of the General Body of the Society in favour Mr. Anwar Shah, President of Rudra Educational Institute Samitifor obtaining MSC from this Commission.
- 4. As per the information supplied by the petitioner unaided institution with regard to students' strength, it is mentioned that during the academic year 2022-

- 23, out of the total 258 students, 27 students were from the Muslim minority community, 02 students were from the Sikhminority community, 18 student were from the Jain minority community and 211 students were Hindu. During the academic year 2023-24, out of the total 266 students, 29 students were from the Muslim minority community, 02 student were from the Sikh minority community, 19 student were from the Jain minority community and 216 students were Hindu. During the academic year 2024-25, out of the total 261 students, 26 students were from the Muslim minority community, 02 student were from the Sikh minority community, 20 student were from the Jain minority community and 213 students were Hindu. It is relevant to mention here that during the academic year 2022-23, out of 24 teachers,04 teachers were from the Muslim Minority community, 01 teacher was from the Sikhminority community, 01 teacher was from the Jain minority community and 18 teachers were Hindu. During the academic year 2023-24, out of 24 teachers, 04 teachers were from the Muslim Minority community, 01 teacher was from the Sikh minority community, 01 teacher was from the Jain minority community and 18 teachers were Hindu and during the academic year 2024-25, out of 26 teachers, 05 teachers were from the Muslim Minority community, 01 teacher was from the Sikh minority community, 02 teachers were from the Jain minority community and 19 teachers were Hindu.
- 5. It is stated in the petition that on dated 13.08.2024, the petitioner institution has applied to the State Competent Authority for grant of NOC which was received by the State Competent Authority on 13.08.2024 and the said application is still pending before the State Competent Authority. The State Competent Authority has not granted NOC in favour of the petitioner institution till now and also not rejected the said application and not communicated the same to the petitioner. After 90 days from the receipt of the application for grant of NOC, the petitioner has filed this petition for grant of MSC to this Commission straightway as per the provisions of Section 10 and 11(f) of National Commission for Minority Educational Institutions (in short 'NCMEI') Act, 2004.
- 6. After service of registered notice / email dated 24.03.2025 and 14.08.2025, response has sent an email dated 19.05.2025 attaching therewith a copy of letter dated 19.5.2025 of Dy. Director, Backward Classes & Minority Welfare, Madhya Pradesh stating therein that due to non-receipt of application in the prescribed format, no action could be taken on the application of NOC. Thereafter in the facts and circumstances of the case, Commission deemed fit and proper that physical inspection report alongwith recommendation may be obtained from the Committee constituted by this Commission for issuance of MSC to the petitioner institution vide order dated 20.05.2025. After service of letter/emails to the physical inspection committee dated 05.06.2025, Physical Inspection Committee, has sent letter dated 01.08.2025, which was received by post in the Commission's Office on dated 18.08.2025 which was duly signed by members of the physical Inspection Committee wherein they have recommended to grant minority status certificate to the petitioner institution.
- 7. The petitioner institution has applied for grant of minority status certificate on the ground that the same has been established primarily for the benefit of the members of the Muslim minority community and is being administered by Rudra Educational Institute Samitiwhich is managed and run by the members of the Muslim minority community. The aforesaid averments made in the petition find ample corroboration from the documentary evidence produced on behalf of the petitioner institution and the affidavit of Mr. Anwar Shah, President of Rudra Educational Institute Samiti.
- 8. Hon'ble Apex Court, various High Courts as well as this Commission in case of Buckley Primary School, Cuttack, Orissa Vs. Government of Orissa (order passed by the Commission in Case No. 1320 of 2009 dated 6.7.2010)

have categorically held that the percentage of admission of students from notified minority community in a minority educational institution is not an indicia for determining the minority status of such institution. This Commission has also decided that there must be reasonable strength of students of particular minority community in a minority educational institution. The percentage could be determined based on the actual proportion of specific minority community in the State population as per prevailing census. Population of Muslim minority community in the State of Madhya Pradesh as per the census of 2011 is 6.57%.

- 9. I have perused the Certified Copy of Memorandum of Association of the petitioner Societyissued byAssistant Registrar of Societies,Gwalior dated 16.08.2022, which is before filing of NOC application U/s 10 of the NCMEI Act, 2004 dated 13.08.2024 and also petition for grant of MSC dated 28.02.2025. So, it is clear that the amendment has been done before the application filed before the State Competent Authority U/s 10 of the NCMEI Act, 2004 and also petition for grant of MSC before this Commission.
- 10. The Certified Copy of Memorandum of Association and all the documents produced by the petitioner institution clearly reflect that the beneficiaries of the petitioner institution are primarily the members of the Muslim minority community. In addition, the said facts also stand proved from the documents and affidavit filed by the petitioner. There is no document on record to rebut the documentary evidence produced on behalf of the petitioner institution.
- 11. Relying on the said unrebutted evidence produced on behalf of the petitioner, we find and hold that City Public College of Education, Plot No. 40 MIN2, Street No. Shadhora, Village- Muhal Dhehar, Post Shadhora, District Ashok Nagar, Madhya Pradesh 473330run by Rudra Educational Institute Samitiis eligible for grant of minority status on religious basis. The evidence also proves that the said educational institution was established with the main objective of sub-serving the interests of the Muslim minority community.
- 12. Consequently, City Public College of Education, Plot No. 40 MIN2, Street No. Shadhora, Village- Muhal Dhehar, Post Shadhora, District Ashok Nagar, Madhya Pradesh 473330is declared as an unaided minority educational institution covered under Article 30 of the Constitution of India within the meaning of Section 2(g) of the National Commission for Minority Educational Institutions Act, 2004."
- 13. A minority status certificate be issued accordingly.
- 14. In view of the above, the present petition is disposed of in accordance with this order.
