4. The petitioner has filed a copy of letter dated 16.6.2015 issued by NCTE granting recognition to the petitioner institution from the academic session 2015-16.

5. Petitioner has not filed original Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission.

6. The petitioner has not supplied correct information against Col. No. 5 of the petition though the petitioner has earlier applied for grant of minority status certificate before this Commission in Case No. 91 of 2025.

7. Accordingly, this petition is not maintainable. The petition is dismissed in default. Petitioner be informed accordingly. Record of Case No. 91 of 2025 be tagged with the record of this case.
