It transpires from the petition that on 20.8.2025, the petitioner institution has applied for grant of No Objection Certificate to the State Competent Authority i.e. Additional Chief Secretary, Basic Education Department, Govt. of Uttar Pradesh, Vidya Bhawan, Nishantganj, Lucknow, Uttar Pradesh - 226007, which was received by the respondent on 25.8.2025. The said petition is still pending as per the petitioner institution. The petitioner has waited sufficiently for period of 90 days as per Section 10 of NCMEI Act, 2004, before filing this petition. The petitioner has already filed the proof of delivery of track consignment to the respondent.

3. The petitioner has filed notarized copy of certificate dated 3.10.2024 issued by District Basic Education Officer, Ayodhya granting recognition to the petitioner institution for the period 3.10.2024 to 3.10.2025.

4. Petitioner has filed Resolution Passed by the Governing Body to obtain Minority Status Certificate from this Commission and envelope with postage for sending notice to the State Competent Authority.

5. It also transpires from the petition that the petitioner Institute is an unaided institution (Middle).

6. During the academic year 2023-24, out of total 551 students, 10 students were from the Christian minority community, in the year 2024-25, out of total 534 students, 15 students were from the Christian minority community and in the year 2025-26, out of total 516 students, 20 students are from the Muslim minority community.
