An application has been received by post on 24.11.2025 from the petitioner mentioned above for grant of minority status certificate to St. Joseph of Cluny School - CBSE, Thirukanchi Road, Pondicherry, Puducherry. It be registered.

2. It is mentioned in the application that on 18.1.2024, the petitioner institution has applied for grant of No Objection Certificate to the State Competent Authority.

3. The Additional Secretary, School Education Department, Puducherry vide letter dated 6.9.2024 has granted No Objection Certificate to the petitioner institution.

4. The petitioner has filed a copy of letter dated 28.6.2025 issued by CBSE granting affiliation to the petitioner institution for the period 1.4.2026 to 31.3.2031.

5. It also transpires from the petition that the petitioner Institute is an unaided institution (Higher Secondary).

6. During the academic year 2022-23, out of total 1734 students, 164 students were from the Christian minority community, in the year 2023-24, out of total 2171 students, 225 students were from the Christian minority community, in the year 2024-25, out of total 2467 students, 253 students were from the Christian minority community and in the year 2025-26, out of total 2598 students, 253 students are from the Christian minority community.

7. The petitioner has not filed a copy of the application submitted before the State Competent Authority for grant of NOC and also not filed proof of delivery of the said application. The petitioner has also not filed Affidavit and Governing Body Resolution.

8. The petition is also incomplete as the petitioner has not mentioned complete address against Col. No. 1(b) of the application.

9. Hence, the petition is not maintainable. Accordingly the petition is dismissed in default. Petitioner be informed accordingly.
