Though this case was fixed for final arguments, it transpires from the record that there is variance of students' details as mentioned in the application format and in the Physical Inspection Report sent by the Physical Inspection Committee.

It is stated in the application format that during the academic year 2021-22, out of total 1427 students, 29 students were from the Christian minority community, in the year 2022-23, out of total 1491 students, 24 students were from the Christian minority community and in the year 2023-24, out of total 1543 students, 27 students were from the Christian minority community.

In the Physical Inspection Report, it is mentioned that during the year 2023, out of total 41 students, 01 student was from the Christian minority community, in the year 2024, out of total 1203 students, 32 students were from the Christian minority community and in the year 2025, out of total 1122 students, 30 students were from the Christian minority community.

Learned counsel for the petitioner has prayed for time to file clarification in this regard within two week. Time prayed for is allowed.

Office is directed that after receipt of the clarification affidavit from the learned counsel for the petitioner, issue letter to the members of the physical inspection committee for filing their response.
