**VACANCY CIRCULAR**

Subject: Filling up of vacancies of various posts on deputation basis in the National Commission for Minority Educational Institutions (NCMEI), New Delhi, a Statutory Body created under an Act of Parliament – Calling for applications - regarding

Central Government (Ministry of Education) in exercise of the powers conferred by the Section 6 of the National Commission for Minority Educational Institutions Act, 2004 (2 of 2005) has framed and issued the Notification dated 12.7.2016 relating to National Commission for Minority Educational Institutions (Group-A, Group-B and Group-C posts) Recruitment Rules, 2016, which was published in the Gazette of India (Extraordinary) on 13.7.2016. Accordingly, the Central Government (Ministry of Education) proposes to fill up vacancy for the various posts on deputation basis in the National Commission for Minority Educational Institutions (NCMEI), New Delhi, a Statutory quasi-judicial Body created under an Act of Parliament under Ministry of Education, the details of which along with their eligibility criteria are given as under: -

5. Regulation of pay and other terms of deputation: The pay of the selected candidate will be regulated under the provisions contained in the DoP&T O.M. No.6/8/2009-Estt.(Pay II) dated 17/06/2010 as amended time to time.

6. Age-limit: The maximum age-limit for appointment on deputation basis shall not be exceeding fifty-six (56) years as on the closing date of receipt of applications.

7. Period of deputation: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/Department of the Central Government shall be a period of upto 5 (five) years beyond that it will be regulated under the provisions contained in the DoP&T O.M. No.6/8/2009-Estt. (Pay II) dated 17/06/2010 as amended time to time.

8. Reservation of SC/ST: No provision for reservation exists for the posts to be filled up on deputation basis.

9. Relaxation granted to eligibility condition vide order No. 7-2/2026-MC dated 23.03.2026 is applicable for the abovementioned posts.

10. Duly filled application in the prescribed proforma (Annexure-I) of the eligible candidates whose services can be spared immediately on selection, together with the certificate from the Forwarding Authority (in proforma Annexure-II) along with

the following documents:

- i. Integrity certificate
  - ii. List of major/minor penalties imposed if any, on the official during the last 10 years; (if no penalty has been imposed a 'Nil' certificate should be enclosed).
  - iii. Vigilance clearance certificate.
  - iv. Attested photocopies of the ACRs for the last five years (2021-22 to 2025-26) (each page attested by an officer not below the rank of an Under Secretary to the Govt. of India).
11. The applications, along with relevant documents in support of qualifications and experience, may be forwarded to "The Director (Minority Cell), Department of Higher Education, Ministry of Education, Room No. 6, 4th Floor, Jeevan Deep Building, Parliament Street, New Delhi – 110001".
12. It is requested that the application(s) of the eligible candidate(s) may be forward so as to reach the Minority Cell by 30<sup>th</sup> April, 2026.
13. Applications not forwarded through proper channel or those received beyond the closing date or without the requisite certificates/documents as indicated vide para 8/above, will not be entertained and shall be rejected summarily. No advance copy of the application shall be entertained.

Note: The applicant, who is desire for appointment on deputation basis in NCMEI shall not be entitled for General Pool Residential Accommodation (GPRA) and also the Commission is not listed with the Central Government Health Scheme (CGHS).
