Today an email has been received from the Additional Chief Secretary, Higher Education Department, Chandigarh, stating therein that the Government vide letter dated 20.11.2025 was constituted a committee comprising of Sh. Shyamal Misra, IAS (HY:1996) and Sh. Kuldeep Singh, Accounts Officer, O/o. DGHE, Haryana for conducting inspection, audit and assessment under the provisions of Section 44(1) and Section 44(2) of Haryana Private Universities Act, 2006. The report of the said committee is awaited.

He has further submitted that one more committee comprising Sh. Shyamal Misra, IAS (HY:1996) and Sh. Sanjay Kumar, IAS (HY:1997) was constituted under Section 46 of Haryana Private Universities Act, 2006 to conduct inquiry in the matter (vide this office memo no. 10/11-2025 (KWE-812155) UNP (5) dated 09.01.2026).

The Committee submitted in its report on 02.02.2026 which was considered by the competent authority and a show-cause notice dated 11.02.2026 was served to the Chancellor, Vice Chancellor, Registrar of Al-Falah University, Faridabad, and Al-Falah Charitable Trust through its managing Trustee (Mr. Jawad Ahmad Siddiqui), as to why action should not be initiated against the Al-Falah University.

Learned counsel for the respondent university submitted that he has filed reply of the aforesaid show-cause notice dated 24.02.2026. Copy of the same has not been provided to the Commission. He is directed to do so.

On 05.02.2026, Respondent no. 2 was directed to apprise the Commission about the status of the report of the Committee constituted by the Government of Haryana but no response/ reply has been received on their behalf. He is also directed to do so. Respondent no.2 is directed to file a copy of inquiry report which was conducted under Section 46 of Haryana Private Universities Act, 2006.

A bare reading the aforesaid email makes it clear that the Competent authority appointed Sh. Amit Kumar Agrawal, IAS(HY:2003) as Administrator of Al-Falah University, Faridabad for a period of three years in accordance with the provisions of the Haryana Private Universities Act, 2006 vide order dated 17.03.2026. Accordingly, he has taken over the charge as Administrator, Al-Falah University, Dhauj, Faridabad on 18.03.2026 and the University is currently functioning under the supervision of the Administrator.

Al-Falah Charitable Trust, New Delhi and Al-Falah University have filed petitions bearing no. 3437 of 2026 and 8865 of 2026 before the Hon'ble Punjab and Haryana High Court, Chandigarh challenging the appointment of the Administrator.

Learned counsel for the respondent no. 1 admitted that the petition bearing no. 3437 of 2026 and 5155 of 2026 have been filed by the respondent no. 1. He has further submitted that no such aforesaid petition bearing no. 8865 of 2026 has been filed by him. He is directed to file certified copies of the said petitions on or before the next date of hearing.

It is pertinent to mention here that Al-Falah University, Haryana declared as a minority institution by the NCMEI as well as by the State Government of Haryana.

Respondent no. 2 is directed to supply copy of the aforesaid email to the learned counsel for the respondent no. 1 for filing rejoinder, if any. Let the same be filed on or before the next date.

Learned counsel for the respondent no. 1 seeks time to file reply in terms of order dated 05.02.2026. Time prayed for is allowed.
