**ORDER**

1. This petition has been received on 04.12.2024 by hand through Mr. Junais P., Advocate of the petitioner institution for grant of Minority Status Certificate (in short 'MSC') to Ursuline English Medium School, Silli, Muri, Ranchi District, Jharkhand-835 101.
2. Learned counsel for the petitioner filed an affidavit of Eve Justina Romould, President of Gyan Deep Trust in support of the averments made in the petition and also to prove that the beneficiaries of the petitioner institution are members of the Christian minority community. She has also filed separate affidavit of Eve Justina Romould stating therein that the petitioner institution shall not deny admission of eligible candidate of the Christian minority community subject to the eligibility of the students and availability of the accommodation in the petitioner institution.
3. Learned counsel for the petitioner has filed notarized copy of Unique ID No. : JH/2017/0171145 of the petitioner Trust as given by the Niti Aayog Portal NGO Darpan, Original copy of application dated 21.03.2024 by hand to the State Competent Authority, notarized copies of Trust Deed alongwith list of founding members, Rules & Regulations, Deed of Amendment of Trust Deed on dated 08.11.2023 alongwith list of present members of the Trust, notarized copy of recognition order dated 11.09.2024 issued by the Chief Executive & Secretary, CISCE, granting affiliation to the unaided petitioner institution and resolution of the General Body of the the Trust in favour of Eve Justina Romould, President of Gyan Deep Trust for obtaining MSC from this Commission.
4. As per the information supplied by the petitioner unaided institution with regard to students strength as on Academic Year 2021-22, it is mentioned that out of total 969 students, 43 students were from the Muslim minority community, 82 students were from the Christian minority community, 01 student was from the Sikh minority community and 843 students were Hindu. In the year 2022-23, it is mentioned that out of total 978 students, 48 students were from the Muslim minority community, 80 students were from the Christian minority community and 850 students were Hindu. In the year 2023-24, it is mentioned that out of total 889 students, 38 students were from the Muslim minority community, 80 students were from the Christian minority

community, 01 student was from the Sikh minority community and 770 students were Hindu and in the year 2024-25, it is mentioned that out of total 891 students, 39 students were from the Muslim minority community, 81 students were from the Christian minority community, 02 students were from the Sikh minority community and 769 students were Hindu. It is relevant to mention here that during the academic year 2021-22, out of the total 27 teachers, 12 teachers were from the Christian minority community and 15 teachers were Hindu. In the academic year 2022-23, out of the total 28 teachers, 14 teachers were from the Christian minority community and 14 teachers were Hindu. In the academic year 2023-24, out of the total 29 teachers, 14 teachers were from the Christian minority community and 15 teachers were Hindu and in the academic year 2024-25, out of the total 29 teachers, 14 teachers were from the Christian minority community and 15 teachers were Hindu.

5. It is stated in the petition that on dated 21.03.2024, the petitioner institution has applied to the State Competent Authority for grant of NOC which was received by State Competent Authority on 21.03.2024 and the said application is still pending before the State Competent Authority. The State Competent Authority has not granted NOC in favour of the petitioner institution till now and also not rejected the said application and not communicated the same to the petitioner. After 90 days from the receipt of the application for grant of NOC, the petitioner has filed this petition for grant of MSC to this Commission straightway as per the provisions of Section 10 and 11(f) of National Commission for Minority Educational Institutions (in short 'NCMEI') Act, 2004.
6. After service of registered notice / email dated 17.01.2025, no reply/ response has received from the respondent. Thereafter in the facts and circumstances of the case, Commission deemed fit and proper that physical inspection report alongwith recommendation may be obtained from the Committee constituted by this Commission for issuance of MSC to the petitioner institution vide order dated 05.05.2025. After service of letter/emails to the physical inspection committee dated 13.05.2025 and reminders dated 22.08.2025, 08.10.2025, 04.12.2025 and 27.02.2026, Physical Inspection Committee, has sent letter dated 17.02.2026, which was received by post in the Commission's Office on dated 23.02.2025 and by email on which was duly signed by members of the physical Inspection Committee wherein they have recommended to grant minority status certificate to the petitioner institution.
7. Heard the Learned Counsel for the petitioner, perused the pleading of the petition, the documents filed by the petitioner and affidavit Eve Justina Romould, President of Gyan Deep Trust.
8. Hon'ble Apex Court, various High Courts as well as this Commission in case of Buckley Primary School, Cuttack, Orissa Vs. Government of Orissa (order passed by the Commission in Case No. 1320 of 2009 dated 6.7.2010) have categorically held that the percentage of admission of students from notified minority community in a minority educational institution is not an indicia for determining the minority status of such institution. This Commission has also decided that there must be reasonable strength of students of particular minority community in a minority educational institution. The percentage could be determined based on the actual proportion of specific minority community in the State population as per prevailing census. Population of Christian minority community in the State of Jharkhand as per the census of 2011 is 4.30%.
9. The petitioner institution has applied for grant of minority status certificate on the ground that the same has been established primarily for the benefit of the members

of the Christian minority community and is being administered Gyan Deep Trust which is managed and run by the members of the Christian minority community. The aforesaid averments made in the petition find ample corroboration from the documentary evidence produced on behalf of the petitioner institution and the affidavit of Eve Justina Romould, President of Gyan Deep Trust.

10. I have perused the Amended Trust Deed of the petitioner institution which was registered before the District Sub-Registrar Office, Ranchi, Jharkhand, on dated 08.11.2023 which is before the filing of NOC applications U/s 10 of the NCMEI Act, 2004 dated 21.03.2024 and petition for grant of MSC on dated 04.12.2024. So it is clear that the amendment has been done before the application filed before the State Competent Authority U/s 10 of the NCMEI Act, 2004 and also petition for grant of MSC before this Commission.
11. The Amended Trust Deed dated 08.11.2023 and all the documents produced by the petitioner Gyan Deep Trust clearly reflects that the beneficiaries of the petitioner institution are primarily the members of the Christian minority community. In addition, the said facts also stands proved from the documents and affidavit filed by the petitioner. There is no document on record to rebut the documentary evidence produced on behalf of the petitioner institution.
12. Relying on the said un rebutted evidence produced on behalf of the petitioner, we find and hold that Ursuline English Medium School, Silli, Muri, Ranchi District, Jharkhand- 835 101 run by Gyan Deep Trust is eligible for grant of minority status on religious basis. The evidence also proves that the said educational institution was established with the main objective of sub-serving the interests of the Christian minority community.
13. Consequently, Ursuline English Medium School, Silli, Muri, Ranchi District, Jharkhand- 835101 is declared as an unaided minority educational institution covered under Article 30 of the Constitution of India within the meaning of Section 2(g) of the National Commission for Minority Educational Institutions Act, 2004.
14. A minority status certificate be issued accordingly.
15. In view of the above, the present petition is disposed of in accordance with this order.
