

FAQs for NIMCET Registration

Question 1: Is it mandatory to have Mathematics or Statistics course in UG?

Answer: Yes, any course relevant to Mathematics or Statistics in **UG** is mandatory for NIMCET irrespective of Maths course in 12th standard. Courses like Discrete Maths, Discrete Structures, Business Mathematics, Probability, Stats for Business Economics, Numerical Methods, etc will be considered for eligibility.

Question 2: If I complete Diploma after 10th standard and directly joined in 2nd year UG degree, will I be eligible for NIMCET?

Answer: Yes, Diploma + 2 Years UG degree will be considered as eligible.

Question 3: If I have CGPA between 6.0 to 6.49 and my university gives percentage conversion formula, can I be considered eligible?

Answer: CGPA to Percentage conversion is strictly NOT allowed. Whatever is printed on the certificate will be considered final. If both CGPA and Percentage are printed, the better one can be considered.

Question 4: I have done my UG degree from Open University which is UGC/AICTE approved, will I be eligible for NIMCET?

Answer: Yes, any UG degree from UGC/AICTE approved institute will be considered as eligible.

Question 5: If my university gives group wise CGPAs instead of overall CGPA, can NIMCET consider by groups CGPA individually?

Answer: Average CGPA of all groups will be considered for eligibility.

Question 6: Can I apply even if I my final semester results are pending?

Answer: Yes, you can apply, subject to the condition that you should satisfy the eligibility criteria after your final results. During counselling you need to submit the certificate as per the proforma given in Annexure-V

Question 7: Do I need to upload OBC/EWS certificates issued after 1st April, 2026?

Answer: For applying exam, previous year certificates can be uploaded. However, during the counselling and certificate verification, it is mandatory to produce latest Caste Certificate issued after 1st April 2026

Question 8: I have semester wise marks sheets and in online application form, it asks to upload year wise marks sheet. What should I do upload?

Answer: You can merge first two semester mark sheets and upload under first year. Same way, do it for remaining semesters. If you do not have last semester marks sheet, you can upload only fifth semester marks sheet under 3rd year.

Question 9: I have EWS certificate issued by state government. Can I upload it for NIMCET?

Answer: It is preferred to have Central EWS format. For applying for exam, you can use state format.

Question 10: I am unable to upload Photo ID as it says "Human face not recognized". What should I do?

Answer: Please clear the cache files and cookies from the browser and then try to upload the ID.

Question 11: I have made the payment and the amount is deducted from the account. However, the status in the application shows as "Payment failed". What should I do?

Answer: After making the payment, please wait for 5 working days. After that you refresh your page and check the status. If it is still pending, please drop us an email.

Question 12: My university doesn't provide semester wise or year wise marks sheet. It gives only consolidated mark sheet. Can I upload the same consolidated marks sheet in all three years?

Answer: Yes, you can upload same certificate in all places wherever it asks for mark sheets.

Question 13: After completing the registration, I haven't received the login credentials in my mail?

Answer: Please check the SPAM folder of your email.

Question 14: I did not do self-attestation on the documents while uploading. Will my application be rejected?

Answer: No, the application won't be rejected as you can upload attested documents during the edit window mentioned in the brochure.

Question 15: I am in my final year UG and I have one outstanding backlog of previous semester. Can I still apply for NIMCET 2026?

Answer: Yes, However, you need to clear all subjects when you appear for counselling.

Question 16: My university results are not yet declared and can I get admission without my final certificates?

Answer: Yes, marks sheets and degree certificate will be collected by the individual institutes after the results are out.

Question 17: Do we have NRI quota seats in NIMCET?

Answer: There are NO NRI quota seats in NIMCET.

Question 18: I am PwD candidate and will I be provided Scribe to write the exam?

Answer: Yes, based on your disability, It will be provided. For more information, please wait till the hall ticket generation process.

Question 19: I forgot my NIMCET registration ID and password. How should I recover them?

Answer: After first time registration, the username, password are sent to registered email address as well as to Mobile as SMS. You can always use forget username/password option to get them back.

Question 20: I registered and paid NIMCET application fee but I want to withdraw my application. How can I get refund?

Answer: NIMCET registration fee is NOT REFUNDABLE.

Question 21: I belong to SC/ST and I have a state issued certificate. Can I upload this?

Answer: Yes, State Govt. issued SC/ST certificate can be used for registration and counselling as well.

Question 22: While filling my institute name and place details, application throws error "Incorrect values for institute name". What should I do?

Answer: Please do not use any special characters, only alphabets with space are allowed.

Question 23: Initially the payment status was showing as "Failed/pending" so I made another payment which became success. What about my previous money?

Answer: The additional payment will be refunded.
