Subject :- Visit of 6th State Finance Commission to seek views of the elected representatives/officials of Panchayati Raj Institutions of the Haryana State.

The State Government has constituted 6th State Finance Commission vide notification No. 18/1/2020-2POL dated on 22nd of September, 2020 issued by the Political & Parliamentary Affairs Department and Sh. P. Raghavendra Rao, IAS (Retd.) has been appointed as Chairman and Sh. Vikas Gupta, IAS as Member Secretary. The Commission is required to make recommendations on sharing of State revenues with the Panchayati Raj Institutions and the Urban Local Bodies. The Commission has also to suggest measures needed to improve the financial position of these bodies.



In this process, the Commission would like to hear suggestions on utilisation of public funds by the local bodies and also the means to ensure that the funds proposed for devolution make a decisive impact on on-going development works and for improving governance. Now, with a view to consolidating views and having first hand opinions of the elected representatives of the PRIs and concerned field level official functionaries on the related issues, the Commission proposes to hold series of meetings as per the attached schedule and programme covering all the Panchayati Raj Institutions in the State.
