**URBAN**

- The creation of a multiplicity of bodies operating independently in large Municipal Corporation areas has generated the need for co-ordination between the bodies, for effective utilization of their services and resources.

It is imperative to understand through a study as to the methodology adopted in different states, (notably Karnataka, Maharashtra, Tamil Nadu and UP) for effective co-ordination amongst similar bodies and to give suggestions for Haryana.

**RURAL**

- A study of diversified land use by Haryana Panchayats in addition to leasing out land only for cultivation.

### ➤ Data of ULBs and PRIs

- To improve the financial position of PRIs, strengthen their fiscal autonomy, governance, and coordination with the state. Diversify revenue sources through revised taxes, user fees, and asset leasing. Build capacity through training, digital tools, and performance-based incentives.
- Discussion with agencies assigned with the task of training of elected representatives and officers of PRIs and ULBs.
- Discussion with National Institutes involved in studies/research on PRIs & ULBs.
- Collection of Data of ULBs and PRIs.
- Discussion with NITI Aayog, Ministry of Panchayati Raj/Rural Development and Ministry of Housing & Urban Affairs, Ministry of Finance .
