ORDER

In pursuance of the Central Civil Services (Revised Pay) Rules, 2016 issued by the Ministry of Finance, Department of Expenditure vide G.S.R. No. 721(E) dated 25th July, 2016 regarding fixation of pay in the revised pay structure effective from 01.01.2016 and subsequent instructions in the matter issued vide O.M. No. 1-5/2016-IC dated 29.07.2016, the pay in respect of Shri Naveen Yadav, Joint Director of this Directorate has been revised. The detailed pay fixation, as per option exercised by him under Rule 6(2) of the CCS (RP) Rules, 2016, is as under:

*Shri Naveen Yadav, JD has opted to get his pay fixed in the revised Pay Matrix w.e.f. 03.02.2016 i.e. date of his promotion to the post of Deputy Secretary.

**In case of an employee appointed or promoted in the normal hierarchy or under MACPS during the period between 2nd of January, 2016 and 1st of July, 2016, who didn't draw any increment on 1st day of July, 2016, the next increment shall accrue on 1st day of January, 2017 and henceforth it shall accrue after one year on annual basis. [Rule 10(2)]

2. The revised Pay Matrix effective from 01.01.2016 includes the Dearness Allowance of 125% sanctioned from 01.01.2016 in the pre-revised pay structure. Thus Dearness Allowance in the revised Pay Matrix shall be zero from 01.01.2016. The rate and the date of effect of the first instalment of Dearness Allowance in the revised Pay Matrix shall be as per the orders to be issued in this behalf in future.
3. The decision on the revised rates and the date of effect of all Allowances (other than DA), based on the recommendations of the 7th CPC shall be notified subsequently and separately. Until then, all such Allowances shall continue to be reckoned and paid at the existing rates under the terms & conditions prevailing in the pre-revised pay structure as if the existing pay structure has not been revised under the CCS (RP) Rules, 2016 issued on 25.07.2016.
4. The contributions under the Central Government Employees Group Insurance Scheme (CGEGIS) shall continue to be applicable under the existing rates until further orders.
5. The existing system on interest free advances for Medical Treatment, Travelling Allowance for family of deceased, Travelling Allowances on tour or transfer and Leave Travel Concession shall continue as hitherto.
