ORDER

In pursuance of the Central Civil Services (Revised Pay) Rules, 2016 issued by the Ministry of Finance, Department of Expenditure vide G.S.R. No. 721(E) dated 25th July, 2016 regarding fixation of pay in the revised pay structure effective from 01.01.2016 and subsequent instructions in the matter issued vide O.M. No. 1-5/2016-IC dated 29.07.2016, the pay of the officials working in the 'Assistant Section Officer' Grade of this Directorate has been revised. The detailed pay fixation, as per options exercised by them under Rule 6(2) of the CCS (RP) Rules, 2016, is as under:

Note: The pay fixation order in respect of the officers who have been granted financial upgradation under MACPS will be issued separately, on receipt of options from them.

- All the above officers shall draw next Annual Increment in the revised Pay Matrix on **01.07.2017**.
- The revised Pay Matrix effective from 01.01.2016 includes the Dearness Allowance of 125% sanctioned from 01.01.2016 in the pre-revised pay structure. Thus Dearness Allowance in the revised Pay Matrix shall be zero from 01.01.2016. The rate and the date of effect of the first instalment of Dearness Allowance in the revised Pay Matrix shall be as per the orders to be issued in this behalf in future.

4. The decision on the revised rates and the date of effect of all Allowances (other than DA), based on the recommendations of the 7th CPC shall be notified subsequently and separately. Until then, all such Allowances shall continue to be reckoned and paid at the existing rates under the terms & conditions prevailing in the pre-revised pay structure as if the existing pay structure has not been revised under the CCS (RP) Rules, 2016 issued on 25.07.2016.
5. The contributions under the Central Government Employees Group Insurance Scheme (CGEGIS) shall continue to be applicable under the existing rates until further orders.
6. The existing system on interest free advances for Medical Treatment, Travelling Allowance for family of deceased, Travelling Allowances on tour or transfer and Leave Travel Concession shall continue as hitherto.
7. The 'Statement of Fixation of Pay' in respect of the above mentioned officers has been prepared, one copy thereof will be placed in the Service Books and another copy will be made available to the Pay & Accounts Officer for post-check.
8. This pay fixation is subject to post-audit and recovery of overpayment, if any.


