## Notification

New Delhi, the.... 2016

G.S.R.---. - In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of the Accountant (group 'C') Recruitment Rules, 2002 except as respects thing done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Accountant in the Government of India Presses and Branches under the Directorate of Printing, Ministry of Urban Development, namely:-

Short Title and Commencement. – (i) These rules may be called the Ministry of Urban Development, Directorate of Printing, Government of India Presses and Branches' Accountant (Group '\$) Recruitment Rules, 2015.

(ii) They shall come into force on the date of their publication in the Official Gazette.

Number of posts, classification, pay band and grade pay or pay scale. – The number of posts, their classification, pay band and grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

**Method of recruitment, age limit, educational qualifications etc.** – The method of recruitment, age limit, educational qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.

## Disqualification. - No person,-

- (a) who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person;

shall be eligible for appointment to the posts under these rules:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other ground for so doing, exempt any person from the operation of this rule.

**Power to relax.** – Where the Central Government is of the opinion that it is necessary or expedient to do so, he may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

Saving. – Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Exservicemen, and other categories of persons, in accordance with the orders issued by the Central Government from time to time in this regard.
