This Directorate conducted the Departmental Examination for the post of Accountants in the Directorate of Printing, Government of India Stationary Office and Deptt. of Publications from 24-27th March, 2014. A total of 23 candidates applied for the examination. However, only 16 of them appeared for the examination out of which only five candidates have qualified in all the 7 papers. One candidate, Sh.
