ORDER

In continuation to this Directorate's order No. 1/29/2017-T&P dated 05.12.2017, 11.12.2017, 29.12.2017 issued in compliance of decision of Government to merge 17 Government of India Presses (GIPs)/Government of India Text Book Presses (GITBPs)/Units into 5 GIPs located at Rashtrapati Bhawan, Minto Road, Mayapuri, in New Delhi, Temple Street, Kolkata and Nashik, Maharashtra and dismissal of W.P.(C) No.1534/2021, 1535/2021 and 1537/2021 vide High Court, Delhi's order dated 31.07.2023 and Order No. C-18013/13(1)/2021-A.I dated 23.08.2023, remaining Officers/Staff of the merged presses are transferred to the retained presses as per **Annexure-I** and officers/staff transferred, vide this/earlier orders, are temporarily posted back to the merged presses for winding up work of the press as per **Annexure-II**

2. The seniority of officials redeployed to the retained Presses will be decided as per the Directorate of Printing's OMs dated 27.05.2019 and 25.07.2019. (copies enclosed).
3. Concerned retained presses will look after the administrative matters of the merged press under the supervision of the concerned OIC/Manager of retained press including payment of electricity/water charges, contract charges etc.
4. OIC/Manager of the retained press shall ensure that proper accounting is done for the assets and liabilities of the press and all records are properly documented as per record retention schedule issued by DAR&PG and transferred to the concerned retained press by 29.09.2023, like files, service records, court matters, stock registers, PBRs etc. A guidance material for winding up exercise is enclosed as Annexure-III for reference. A detailed SOP shall follow.
5. The salary, Dearness Allowance & other admissible allowances payable to the employees redeployed as well as retained in the press shall be paid from the Budget Heads of respective retained GIPs to which it has been merged.
6. The retirement benefits of the employees, if not yet paid, will also be paid from the Budget Heads of respective retained GIPs to which it has been merged.
7. Joining Time and TA/DA shall be admissible as per the extant rules for the employees transferred.
8. This issue with the approval of the competent authority.

1	Transfer of officers having all India transfer liability in the existing presses to retained presses	The Officers with all India transfer liability will be transferred to the retained press and if need be redeployed to the existing press for winding up activities.
2.	Winding up of Presses	(i)The team of officers deployed for winding up of the merged presses shall be responsible for proper accounting of assets and liabilities including preparation of list of documents, service records, vigilance/disciplinary cases, court cases, record of permanent nature, audit paras, budget related documents/records etc. of the existing presses to be transferred to the merged/retained press. (ii)The deputed staff shall work under the overall supervision of OIC/Manager of the retained press and shall be responsible to ensure that all records are properly documented and transferred to the retained press. A detailed SOP for winding up shall be communicated soon.
3.	How the seniority of officials in different grades to be determined in the retained presses.	Their seniority will be decided as per the <u>D/o Printing's OMs dated 27.05.2019 and 25.07.2019.</u>
4.	All matters related to press including officials present/past of presses merged with retained presses including administrative/financial/ vigilance/ budget matters etc.	Retained presses to which the press is merged will look after all matters related to administration of the presses merged which <i>inter-alia</i> would include personal matters, court cases, audit-paras, vigilance/disciplinary matters, including payment of electricity/water chargers, contract charges etc. under the overall supervision of the concerned OIC/Manager of retained press.
6	Budget of the merged Press	The modalities concerning work related to verification and closure of budget and accounts besides re appropriation/allocation of additional funds to the retained presses for meeting additional burden, if any, on account of merger shall be provided in due course as formulated by B&A Section of DoP.
