Minutes of the Meeting

Minutes of the Meeting held on 21.11.2025 under the Chairmanship of Hon'ble Minister of State, MoHUA regarding Issues Related to Directorate of Printing and Government of India Presses

A meeting was convened under the Chairmanship of Hon'ble Minister of State, Ministry of Housing & Urban Affairs (MoHUA) on 21 November 2025 at 1:30 PM in Room No. 117, Sankalp Bhawan, to review and deliberate upon issues concerning the Directorate of Printing (DoP) and the functioning of the Government of India Presses (GIPs).

- 2. At the outset, Joint Secretary (PSP) welcomed the Hon'ble Minister of State and all officers present.
- 3. JS (PSP) made a detailed presentation outlining the overall functioning of the Directorate of Printing. Following deliberations on various agenda points, the following decisions were taken:
- 4. The Hon'ble MoS expressed concern over delays in the procurement of machinery for GIP, Minto Road. He directed that NBCC expedite the procurement process for the remaining machines and ensure timely completion of the project.

(Action: NBCC & DoP)

5. The Hon'ble MoS reviewed the status of modernization of retained 4 GIPs as per the 2017 Cabinet decision. It was apprised that the mode of modernization underwent certain changes and the latest proposal for modernization through budgetary support is under active consideration.

The JS has assured that the process be formally initiated by the end of December 2025.

(Action: PSP & DoP)

6. The Hon'ble MoS took note of the acute shortage of technical manpower. It was highlighted that no regular Managers are posted at GIP Minto Road and GIP Temple Street, Kolkata, and one post of Deputy Director (Technical) in DoP is also vacant.

The Hon'ble MoS directed that the promotion processes for the aforementioned posts be expedited. JS (PSP) assured that:

- Promotion processes for Managers/Deputy Directors and Assistant Managers (Admn) will be initiated by 15 December 2025.
- Promotion orders for Deputy Managers will be issued shortly.

(Action: PSP & DoP)

7. The Hon'ble MoS sought clarification regarding delays in recruitment against the revised sanctioned strength issued in September 2024. JS (PSP) informed that reconciliation of staff strength along with identification of posts to be outsourced will be completed by December 2025.

Recruitment of outsourced staff will be initiated thereafter, followed by direct recruitment through SSC/NRA, as applicable.

(Action: DoP & GIPs)

8. The Hon'ble MoS noted low achievement against production targets in GIP Minto Road and GIP Mayapuri. Revised targets will be issued based on latest manpower and machinery status.

(Action: DoP & GIPs)

9. The Hon'ble MoS expressed concern over low realisation of payments against invoices. GIPs will pursue outstanding dues regularly, and a department-wise list of pending bills will be prioritised.

(Action: DoP & GIPs)

10. JS (PSP) informed that GIPs along with the Department of Publication will undergo digitisation to meet modern requirements. Discussions regarding handing over the EPA project to NIC (HUA) are at an advanced stage, and the project will be handed over by December, 2025.

(Action: DoP)

11. The Hon'ble MoS directed the Department to take appropriate action regarding representations received from the GIP Workers' Union.

(Action: DoP)

12. The Hon'ble MoS expressed concern over under-utilisation of Budget and instructed that allocations be utilized effectively.

(Action: DoP)

13. The Hon'ble MoS noted that a large number of court cases are pending in various courts and CAT benches and directed monitoring and timely action.

(Action: DoP)

14. The meeting concluded with a vote of thanks to the Chair and the participants.
