2. The promotion of the above officials shall, however, be subject to the final outcome of **OA No. 846/2023** pending before the Hon'ble Central Administrative Tribunal (CAT), Kolkata Bench, relating to seniority/promotion matters. Further, in terms of DoPT OM No. DOPT-1721625311004 dated 22.07.2024, the promotion shall also remain subject to the final outcome of the *Jarnail Singh* batch of cases pending before the Hon'ble Supreme Court of India.

3. It is further stated that there is no vacancy available in Deptt. of Publication as out of two sanctioned strength of Asstt. Controller, one post has been abolished in terms of the Department of Expenditure's OM No. 7(1)/E.Coord-I/2017(Part.III) dated 04.01.2024, being vacant for more than 05 (five) years. Accordingly, the officials promoted vide this Office Order are liable to be posted in any of the Government of India Presses under administrative control of the Directorate of Printing, depending upon administrative exigencies and availability of vacancies.

4. Since all the above officials are presently posted in the Department of Publication, the Department of Publication is requested to obtain and forward the willingness/acceptance of promotion from the concerned officials to this Directorate latest by 04.06.2026, so that posting orders may be issued on priority basis. It is further clarified that once the promotion is accepted by the concerned official, refusal of posting on the grounds of place of posting or any other reason shall not be entertained.

5. It is also stated that the pay fixation for the post of Assistant Manager (Admn.) in respect of the officers will be carried out by the concerned Presses after acceptance of

the promotion and posting.
