Further, in terms of DoPT OM No. DOPT-1721625311004 dated 22.07.2024, the promotion shall also remain subject to the final outcome of the *Jarnail Singh* batch of cases pending before the Hon'ble Supreme Court of India. The promotion of the above official is further subject to the final outcome of O.A. No. 1591/2026 pending before the Hon'ble CAT PB, New Delhi.
3. It is further stated that the official promoted vide this Office Order is liable to be posted in any of the Government of India Presses under administrative control of the Directorate of Printing, depending upon administrative exigencies and availability of vacancies.
4. Since the above official is presently posted in the Govt. of India Press, Nashik, GIP, Nashik is requested to obtain and forward the willingness/acceptance of promotion along-with the joining report from the concerned official to this Directorate **latest by 24.07.2026**, so that posting orders may be issued on priority basis. It is further clarified that once the promotion is accepted by the concerned official, refusal of posting on the grounds of place of posting or any other reason shall not be entertained.
5. It is also stated that the pay fixation for the post of Assistant Manager (Admn.) in respect of the officer will be carried out by the concerned Presses after acceptance of the promotion and posting.
