(1) That the vehicles shall be used only in a specified area, or on specified routes in the permit. (2) That copies of the time table of the Stage Carriage approved by the State/Regional Transport Authority shall be exhibited on the vehicle

and at specified stands and halts on the route or within the area. (3) That specified standards of comfort and cleanliness shall be maintained in the vehicles.

(11) (i) No motor vehicle shall be fitted with an audio on audio visual device in such a position so that it distracts the attention of driver.

(11) (ii) Such audio-visual device or video or tape recorder shall fitted in such a position that its operations not accessible to driver.

(11) (iii) NO loudspeaker attached to any of such devices shall fit in driver's cabin in case of a Stage carriage.
