(4) That fares shall be charged in accordance with the approved fare table.

(5) That the vehicle to which the permit relates is not driven speed exceeding the speed permitted under this Act.

(6) That the vehicle to which the permit rerates is not driven in contravention so Sec.5 or Sec.113

(7) That its holder shall not use a Stage Carriage in a public place for carrying or intending to carry passengers unless it carries

(8) That the service of Stage Carriage shall be regularly operated on the specified route in accordance with the approved time-table. (9) No owner shall employ any person to act as an agent for sale of tickets for travel by public service vehicle unless that person holds

(10) Any variation in route shall not be allowed beyond the limit as provided in the provision to clause (xxii) of sub- section (2) of

(11) (i) No motor vehicle shall be fitted with an audio on audio visual device in such a position so that it distracts the attention of driver.

(11) (ii) Such audio-visual device or video or tape recorder shall fitted in such a position that its operations not accessible to driver.
