TERMS AND CONDITIONS

PERMIT NO. BR2023-SC-3158A

VEHICLE NO. BR06PC8741

- (1) That the vehicles shall be used only in a specified area, or on specified routes in the permit.
- (2) That copies of the time table of the Stage Carriage approved by the State/Regional Transport Authority shall be exhibited on the vehicle and at specified stands and halts on the route or within the area.
- (3) That specified standards of comfort and cleanliness shall be maintained in the vehicles.
- (4) That fares shall be charged in accordance with the approved fare table.
- (5) That the vehicle to which the permit relates is not driven speed exceeding the speed permitted under this Act.
- (6) That the vehicle to which the permit rerates is not driven in contravention so Sec.5 or Sec.113
- (7) That its holder shall not use a Stage Carriage in a public place for carrying or intending to carry passengers unless it carries
- (8) That the service of Stage Carriage shall be regularly operated on the specified route in accordance with the approved time-table.
- (9) No owner shall employ any person to act as an agent for sale of tickets for travel by public service vehicle unless that person holds
- (10) Any variation in route shall not be allowed beyond the limit as provided in the provision to clause (xxii) of sub- section (2) of
- (11) (i) No motor vehicle shall be fitted with an audio on audio visual device in such a position so that it distracts the attention of driver.
- (11) (ii) Such audio-visual device or video or tape recorder shall fitted in such a position that its operations not accessible to driver.
- (11) (iii) NO loudspeaker attached to any of such devices shall fit in driver's cabin in case of a Stage carriage.
- (12) Vehicle owner will made available canvasser and agent license within a month to the under sign through affidavit.
- (13) The name of driver and conductor with their mobile number shall be written clearly on both sides of the bus in addition to the name and address of the operator.
- (14) Via of the route shall be written of the vehicle in Urdu also.
- (15) No commercial goods shall be carried on the vehicles.
- (16) Transportation of any inflammable substance is prohibited. Carrying of fire extinguisher will be a must.
- (17) This permit is not valid if the bus violates rule 158 of Bihar Motor Vehicle Rule, 1992
- (18) Vulgar/Obscene/Hurting the sentiments and dignity of women, children, religion, communities/songs, videos will not be allowed in
- (19) It shall be ensured by the permit holder that the driver of the vehicle shall follow the directions notified under Motor Vehicle Driving
- (20) This permit is subject to the conditions laid down in Section 84 of the Act, and in sub-rule(1) of rule 76 the Bihar Motor Vehicles Rules -
- (21) This permit is also subject to condition that:-
- (21) (i)The approved fare-table and time-table of the routes shall be exhibited in the vehicles and on the parking place/stands and halts
- (21) (ii) The arrangements specified in the application for the permit, for housing, maintenance and repairs of the vehicles, and for storage and sage custody of luggage and goods will be maintained.
- (21) (iii)The records and returns shall be submitted to be the Transport Authority as specified by it
- (22) This permit is further subject to other conditions attached to the permit
- (23) The State/Regional Transport Authority may, after giving notice of not less than one month.(i) Vary the conditions of the permit. (ii)
- (24) The permit is valid if and only if accompanied by an authorisation slip indicating the period of validity on the basis of payment of Motor Vehicle Tax and additional M.V.Taxes.
- (25) The permit is issued subject to the condition that difference of tax, if any on final calculations, shall payable along with penalty, if
- (26) Minimum tow seats shall be kept reserved for disabled passengers and shall ensure provision of low footboard for easy
