#### **TERMS AND CONDITIONS**

## **PERMIT NO. BR2023-SC-3331A**

## **VEHICLE NO. BR30F9221**

- (1) That the vehicles shall be used only in a specified area, or on specified routes in the permit.
- (2) That copies of the time table of the Stage Carriage approved by the State/Regional Transport Authority shall be exhibited on the vehicle and at specified stands and halts on the route or within the area.
- (3) That specified standards of comfort and cleanliness shall be maintained in the vehicles.
- (4) That fares shall be charged in accordance with the approved fare table.
- (5) That the vehicle to which the permit relates is not driven speed exceeding the speed permitted under this Act.
- (6) That the vehicle to which the permit rerates is not driven in contravention so Sec.5 or Sec.113
- (7) That its holder shall not use a Stage Carriage in a public place for carrying or intending to carry passengers unless it carries conductor.
- (8) That the service of Stage Carriage shall be regularly operated on the specified route in accordance with the approved time-table.
- (9) No owner shall employ any person to act as an agent for sale of tickets for travel by public service vehicle unless that person holds a valid agents license.
- (10) Any variation in route shall not be allowed beyond the limit as provided in the provision to clause (xxii) of sub-section (2) of Section 72 of the Motor Vehicles Act.
- (11) (i) No motor vehicle shall be fitted with an audio on audio visual device in such a position so that it distracts the attention of driver.
- (11) (ii) Such audio-visual device or video or tape recorder shall fitted in such a position that its operations not accessible to driver.
- (11) (iii) NO loudspeaker attached to any of such devices shall fit in driver's cabin in case of a Stage carriage.
- (12) Vehicle owner will made available canvasser and agent license within a month to the under sign through affidavit.
- (13) The name of driver and conductor with their mobile number shall be written clearly on both sides of the bus in addition to the name and address of the operator.
- (14) Via of the route shall be written of the vehicle in Urdu also.
- (15) No commercial goods shall be carried on the vehicles.
- (16) Transportation of any inflammable substance is prohibited. Carrying of fire extinguisher will be a must.
- (17) This permit is not valid if the bus violates rule 158 of Bihar Motor Vehicle Rule, 1992
- (18) Vulgar/Obscene/Hurting the sentiments and dignity of women, children, religion, communities/songs, videos will not be allowed in the Buses.
- (19) It shall be ensured by the permit holder that the driver of the vehicle shall follow the directions notified under Motor Vehicle Driving Regulation, 2017
- (20) This permit is subject to the conditions laid down in Section 84 of the Act, and in sub-rule(1) of rule 76 the Bihar Motor Vehicles Rules –
- (21) This permit is also subject to condition that:-

- (21) (i)The approved fare-table and time-table of the routes shall be exhibited in the vehicles and on the parking place/stands and halts specified in the application for permit.
- (21) (ii) The arrangements specified in the application for the permit, for housing, maintenance and repairs of the vehicles, and for storage and sage custody of luggage and goods will be maintained.
- (21) (iii)The records and returns shall be submitted to be the Transport Authority as specified by it
- (22) This permit is further subject to other conditions attached to the permit
- (23) The State/Regional Transport Authority may, after giving notice of not less than one month.(i) Vary the conditions of the permit. (ii) Attach to the permit further conditions.
- (24) The permit is valid if and only if accompanied by an authorisation slip indicating the period of validity on the basis of payment of Motor Vehicle Tax and additional M.V.Taxes.
- (25) The permit is issued subject to the condition that difference of tax, if any on final calculations, shall payable along with penalty, if chargeable.
- (26) Minimum tow seats shall be kept reserved for disabled passengers and shall ensure provision of low footboard for easy accessibility.
- (27) Every vehicle owner will keep reserve two seats of the first row for the handicap persons. It will be mentioned near the reserve seats. Vehicles owner shall be ensure and arrange wheel chair for the convenience of the handicap persons.
- (28) Eave teasing is done by the passengers or persons in the public passengers vehicles. if such incident is reported by the victim or the co-passengers to the vehicles squad then the vehicle squad will report to the nearest Police Station Immediately. If it is not done by the vehicle squad then permit will be cancelled.
