- (1) That the vehicles shall be used only in a specified area, or on specified routes in the permit.
- (2) That copies of the time table of the Stage Carriage approved by the State/Regional Transport Authority shall be exhibited on the vehicle and at specified stands and halts on the route or within the area.
- (3) That specified standards of comfort and cleanliness shall be maintained in the vehicles.
- (4) That fares shall be charged in accordance with the approved fare table.
- (5) That the vehicle to which the permit relates is not driven speed exceeding the speed permitted under this Act.
- (6) That the vehicle to which the permit rerates is not driven in contravention so Sec.5 or Sec.113
- (7) That its holder shall not use a Stage Carriage in a public place for carrying or intending to carry passengers unless it carries
- (8) That the service of Stage Carriage shall be regularly operated on the specified route in accordance with the approved time-table.
- (9) No owner shall employ any person to act as an agent for sale of tickets for travel by public service vehicle unless that person holds
- (10) Any variation in route shall not be allowed beyond the limit as provided in the provision to clause (xxii) of sub- section (2) of
- (11) (i) No motor vehicle shall be fitted with an audio on audio visual device in such a position so that it distracts the attention of driver.
- (11) (ii) Such audio-visual device or video or tape recorder shall fitted in such a position that its operations not accessible to driver.
- (11) (iii) NO loudspeaker attached to any of such devices shall fit in driver's cabin in case of a Stage carriage.
