The cut-off date to determine the maximum age limit, essential qualifications & experience will be the last date of submission of application. The period of experience wherever prescribed shall be counted after obtaining the prescribed essential qualifications.
- The remuneration will be consolidated in nature as determined by the competent authority.
- Selection committee duly approved by the competent authority reserves the right to relax the experience criteria in case sufficient numbers of suitable candidates are not available at the time of interview / written test.

Other Terms and Conditions for contractual employment: -

- i. A fixed monthly amount shall be admissible and the remuneration may be regulated as per the terms and conditions of the contract. No other allowances will

- ii. Paid leave of absence may be allowed @ 1.5 days for each completed month of service.
- iii. The term of appointment shall ordinarily be for an initial period of 1 year (extendable yearly maximum upto 3 years, on the basis on the basis of performance and requirement).
