3. Incomplete applications/applications without attested /self-attested copies of academic qualifications, experience, age and category will be summarily rejected.
4. Mere fulfilling the minimum qualification and experience is not sufficient criteria/parameter for selection of candidate.
5. No TA/DA will be admissible for appearing for the interview/Written/Skill Test.
6. A merit list of waitlisted candidates will also be prepared and will be valid for a period of 01 year. CRC-Bhopal has the right/discretion to increase the number of posts. In such case, the candidates from the waitlisted list will be given preference in order of merit.

7. The number of vacancies may increase or decrease. CRC-Bhopal reserves the right to fill or not to fill or partially fill the above vacancies without assigning any reasons whatsoever.
8. CRC-Bhopal may take up the verification of eligibility of the candidate at any point of time prior to or after the completion of the selection process.

Conditions of Contract for Joining:

1. The incumbent will be paid the fixed amount of salary as mentioned in the advertisement. No other allowance such as DA/HRA/etc. and other allowance will be admissible.
2. No TA/DA will be admissible for joining the CRC-Bhopal.
3. This engagement will be purely temporary for a period of 01 year on contractual basis. However, contractual engagement may be terminated any time at the discretion of the Competent Authority, CRC-Bhopal without assigning any reason thereof.
4. The candidate shall be engaged on contract and purely on temporary basis which will not confer any claim for future appointment to any post in the CRC-Bhopal in whatsoever manner. The incumbent will have no right to claim for any regularization or extension/ renewal of engagement in any circumstances.
5. Paid leave of absence may be allowed @1.5 days for each completed month of service.
6. Necessary tax deduction as per Govt. instructions will be made at source.
7. Appointment on full-time basis will be as per working hours of CRC-Bhopal. However, the officer may be required to attend office on holidays or beyond office hours, in case of exigencies and no additional allowance shall be paid for the same.
8. Candidate shall not utilize or publish or disclose or part with, to a third party, any part of the data or information collected for the purpose of the work assigned or during the course of assignment for CRC-Bhopal, without the written consent of CRC-Bhopal.
9. Candidate so engaged shall be bound to handover entire records of assignment to the organization on expiry of contract.
