- 5.3 Quotation should be signed, stamped & properly sealed,
- 5.4 Goods & Service Tax rates will not be considered for assessment,
- 5.5 The bidder should submit the copy of Registration Certificate,
- 5.6 The bidder should submit copy of GST Certificate,
- 5.7 The bidder should submit Annual Turnover certificate of minimum Rs. 5,00,000/-

## 6. Issue of Work Order :

The bidder whose bid is the most responsive (Most appropriate quotations) bidder and whose rate is the lowest (bid) will be ordered.
