## Honourable Speaker,

I now present Part II of the Budget before the August House.

- State's Own Tax Revenue is Rs. 3,26,397 crores for the year 2023-24 as per the Revised Estimates.
- The budget estimate for State's Own Tax Revenue has been fixed at Rs.3,43,040 crores for the financial year 2024-25.

Introducing Uniformity in VAT on across the

It is essential to bring uniformity in the value added tax on diesel and petrol to provide relief to the common Petrol and citizens as well as the industry and trade sectors. Hence it  $^{
m Diesel}$  is proposed to reduce the current tax on diesel from 24 % to State. 21% in the areas of municipal corporations of Brihanmumbai, Thane and Navi Mumbai. Also the current tax rate on petrol is 26 % plus five rupees and twelve paise per litre, which is now proposed to reduce to 25 % plus five rupees and twelve paise per litre.

> Due to this proposal, the price of petrol per litre in the areas of municipal corporations of Thane, Brihanmumbai and Navi Mumbai will be cheaper by approximately 65 paise and that of diesel by approximately Rs. 2.07 per litre.

Exemption from **Profession** Central

There are seven armed forces working in the Central Tax to five Armed Police Force, out of which the armed personnel of the Border Security Force and the Central Reserve Police Force Forces. are exempted from paying Profession Tax.

> Now I propose to exempt the armed soldiers of the remaining five forces i.e. Assam Rifles, Central Industrial Security Force, Indo-Tibetan Border Police, National Security Guard and Sashastra Seema Bal from payment of Profession Tax.

This will benefit approximately twelve thousand soldiers.

Stamp Duty

If it is found to have paid less stamp duty on the registered documents, the penalty levied on the difference in stamp duty amount from the date of execution of the document will be reduced from 2% to 1% per month.

4. Application for stamp duty refund will be made online. Stamp Duty. The time limit for application will be increased from six months to one year from the date of stamp purchase.

I hope that the Honourable Members of this House will support these proposals.
