

Proposal for Administrative and Financial approval for procurement of AMC support for various Software in the Business Intelligence and Data Ware House (BIDW) project of MGSTD, for the period 1st July 2024 to 30th June 2025.

JC, EIU, briefed the PIC that,

1. Economic Intelligence Unit (EIU) of MGSTD is involved in analysis of data for identification of risk parameters and areas of possible tax evasion through Business Intelligence and Data Warehouse (BIDW) project. This project uses various software and hardware and the Annual Maintenance Contract (AMC) of these products are required to get timely replacement of faulty products and to get support to resolve critical issues to ensure business continuity. It is critical for smooth operation of the BIDW system and availability of BIDW solutions which are necessary for continuous analysis of GST data in view of effective GST implementation.
2. The Department had submitted proposal to PIC for procurement of AMC for the period 01.07.2023 to 30.06.2024. Accordingly, in the 74th PIC meeting held on 25/05/2023 Administrative and financial approval was granted for procurement of AMC for hardware and software of BIDW Project for the period 01.07.2023 to 30.06.2024 at a cost of Rs. 89,04,595/- (Rupees Eighty-Nine Lakhs four thousand five hundred ninety-five only) plus applicable taxes thereon as under.

3. Now the department has moved the MGSTD BIDW System on cloud Environment through Cloud Service Providers i.e. M/s. CtrlS Datacenters Limited. As the entire infrastructure is moved to Cloud environment, AMC of HPE Hardware & Software and RHEL Operating system is not required on Cloud Environment, hence same has not been taken in this AMC period. The maintenance of hardware and operating system will be a part of the overall Cloud subscription and the cost for the same is already considered in the Migration Project Cost.
4. After moving on the cloud environment, the AMC of SAS applications and SAP database will be required to be continued, to get technical support, patches, updates, migration support etc.
5. The Software for which AMC is required as below.
 - (a) SAS Applications
 - (b) SAP Sybase Database
6. To procure the AMC of the above software products, AMC quotations are obtained from Original Equipment Manufacturers (OEMs) for the period from 01.07.2024 to 30.06.2025. Accordingly, total cost of procurement of the AMC is as follows.

It is requested that Administrative and Financial approval may be granted for procurement of AMC support from 01.07.2024 to 30.06.2025 the for,



- ii) SAP Sybase Database at a cost of Rs. **11,02,404/-** (Rupees Eleven Lakhs two thousand four hundred four only) plus applicable taxes thereon.

Decision of the PIC:

PIC granted administrative approval for procurement of AMC support for one year by following due procedure, as given below,

- i) SAS Applications at a cost of Rs. **41,78,326/-** (Rupees Forty One lakhs Seventy Eight Thousand Three hundred twenty six only) plus applicable taxes and
- ii) SAP Sybase Database at a cost of Rs. **11,02,404/-** (Rupees Eleven Lakhs two thousand four hundred four only) plus applicable taxes.
