Ref.: Regarding revision of items and norms of assistance from SDRF / NDRF for disaster victims.

Dear Sir,

This bears reference to the communications received previously with regard to the above subject and discussions held during the videoconferencing organized on 6th May, 2020. In this regard this is to bring it to your notice that the items and norms of assistance out of SDRF / NDRF were revised in the year 2015. Moreover in the previous decade the per capita income and standard of living of the masses have witnessed significant positive change. The masses therefore look forward to proactive approach together with better relief package from the state in the event of a disaster incidence.

- 2. In view of the above it is requested that the relief payable to the disaster victims under all the items be enhanced significantly, taking note of the prevailing rate of inflation and change in consumer price index during the previous 05 years. Table depicting suggestive rates of relief admissible out of SDRF is enclosed for your reference.
- 3. It is put forth that most farmers in the state are small and marginal and landslides and floods routinely take major toll of their agricultural land together with the crops therein, particularly during the monsoon period. There being no minimal limit on the relief payable to disaster victims in case of loss of land and most land ownership being small the relief amount works out to be insignificant. It is therefore requested that minimum amount payable to the disaster victims be included in the revised norms of assistance.
- 4. It is further brought to your knowledge that animal rearing is the main source of livelihood for significantly large proportion of the people in the state, particularly in the higher reaches and the same contributes significantly to the

economy of the state. It may kindly be noted that relief admissible in case of loss of farm animals is presently restricted to the upper limit of 03 large or 30 small milch animals or 03 large or 06 small draught animals per household irrespective of whether a household has lost larger number of animals. In view of the ground realities in the hills, it is requested that the relief be made admissible for actual number of animals lost in the natural calamity. This would help the disaster affected families in tiding over economic hardships and reduce misery of the disaster affected population.

- 5. It is brought to your notice that traditional and locally abundant building material, stone and wood, is not available easily and economically in the hills due to various environmental restrictions and forest conservation laws. All the construction material, cement, sand, grit and iron bars, has therefore to be transported from the plains. Moreover, large proportion of the construction works are at significant distance from the road head and manual transportation adds to the cost of building material. The existing norms of relief in case of loss of residential houses due to disaster incidence no doubt takes cognizance of this ground reality but the relief amount payable in the hills is only 7.2 percent more (Rs. 1,01,900) than what is payable in the plains (Rs. 95,100) which does not account for the transportation cost generally incurred in the hills. It is therefore requested that the relief admissible in case of loss of residential houses in the hills be at least 20 percent more than what is admissible in the
- In the end it would be worthwhile to suggest that in view of increasing global acceptability of insurance as a potential risk reduction tool, the payment of disaster insurance premiums be allowed out of SDRF.
