One of the key functions of the ICSI is to conduct Company Secretaries Examinations in three stages, viz., Foundation Programme, Executive Programme and Professional Programme, twice a year on all-India basis in the months of June and December. Accordingly, the June, 2021 Company Secretaries Examinations are scheduled from Tuesday, the 10<sup>th</sup> August, 2021 to 20<sup>th</sup> August, 2021 in the morning session from 10:00 A.M. to 1:00 P.M. (Time Table attached as Annexure - 'A') at 265 examination centres all over India and one examination centre abroad.

We are to inform that Company Secretaries Examinations would be held in the State of Uttarakhand simultaneously with all other examination centres across India. The schedule of June, 2021 Company Secretaries Examinations from 10<sup>th</sup> August, 2021 to 20<sup>th</sup> August, 2021 has been informed to all concerned including the candidates, examination centres and universities in Uttarakhand and across the nation. The Examination will be held at one examination centre in Uttarakhand. The name of the city where examinations are to be held is annexed as Annexure - 'B'.
