### Subject: Declaration of results of the entrance exam for admission to the MBA(IB) course of the Indian Institute of foreign Trade (IIFT) for 2023-25.

National Testing Agency(NTA) held the entrance exam for admission to the MBA(IB) course of the Indian Institute of foreign Trade (IIFT) for the year 2023-25, in CBT mode, at 163 exam centres located in 63 cities across India on 18.12.2022, in the CBT mode.

Details regarding conduct of exam are as follows:

- A Control Room was opened and 2 National Coordinators, 35 Zonal Co-ordinators, 18 Regional Co-ordinators, 63 City Coordinators, 163 Observers and 57 Deputy Observers were positioned.
- Live CCTV- CCTV Surveillance was commissioned in 163 examination centres to curb malpractices in the examinations. The NTA made arrangements for live viewing at remote location and recording of CCTVs Systems of all examination centres at control room situated in the NTA.
- In order to stop cheating using mobile networks, Jammers were installed in all the Centres. A total of about 1030 jammers were put in place.

The exam was held smoothly with the support and co-operation of all the stakeholders.

The exam was conducted taking all necessary precautions, observing social distancing, sanitisation, staggered entry of candidates into the exam hall, provision of masks to candidates, etc, laid down by the Govt. of India.
