INFORMATION BULLETIN FOR COUNSELING OF MEDICAL/ DENTAL- UG (MBBS & BDS) CHHATTISGARH STATE QUOTA SEATS-2023

GENERAL INFORMATION

Qualified and eligible candidates are required to register on the CGDME counseling website i.e. <u>www.cgdme.admissions.nic.in</u> to participate in the counseling process for allotment of seats. CGDME does not allot any seat either on nomination basis or manually.

a) Candidates are deemed to have read, agreed and accepted the Scheme of Counseling and the terms and conditions of the Counseling scheme for NEET-UG Counseling on completing the online submission of application/registration form.

b) Application for NEET – UG Counseling can only be submitted online through CGDME counseling website <u>www.cgdme.admissions.nic.in</u>.
Application submitted through any other mode shall not be entertained.

c) Candidates are further advised to fill the application form on their own on the CGDME counseling website and not through any agent or third party.

d) A candidate can submit NEET-UG Counseling application/registration form only once. Any candidate found to have submitted more than one application/registration form for NEET-UG Counseling shall be debarred from NEET-UG Counseling allotment process, his/her candidature shall be canceled and further action as deemed appropriate by the CGDME or CG govt shall be taken.

e) The Security Deposit will be forfeited if a candidate who has been allotted a seat in the Second Round or subsequent rounds and does not join the respective institution. Also, the Security Deposit will be forfeited if the admission gets canceled due to any reason. For example, in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later canceled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of scrutiny/ admission (within stipulated time)

f) Candidates may kindly note that registering for NEET-UG Counseling does not confer any automatic rights to secure an Undergraduate seat. The selection and admission to Undergraduate seats in a medical Institution recognized for running Under Graduate courses as per Indian Medical Council Act, 1956 is subject to fulfilling the merit, admission criteria, eligibility, and such criteria as may be prescribed by medical institutions, Medical Council of India/ National Medical commission, Central Government and State Government.

g) Candidates should ensure that all the information filled during the online submission of application/registration form is correct and factual. Information provided by the candidates in the online application/registration form shall be treated as correct and self-certified and CGDME shall not entertain, under any circumstances, any request for change in the information provided by the candidates.

h) CGDME does not change/ edit /modify/alter any information (name, DoB, category, nationality, contact details etc.) entered by the candidates at the time of online submission of application/registration form for Counseling under any circumstances. The data entered by the candidate at the time of registration on NTA portal will be pre-populated and will be used for Counseling purposes.

i) Candidates are advised to confirm their eligibility/domicile status before registering on CGDME website for All seats of Govt Medical Colleges and State Govt Quota seats of Private Medical and Private Dental Colleges before opting for their seats.

j) Candidates are advised to confirm the fee structure/ any other additional fee

from the colleges especially Private Colleges. The above information must be confirmed by the candidate before filling the choices.

 k) Candidates are advised to be in touch with the CGDME counseling website (www.cgdme.admissions.nic.in) for Schedule / latest updates / Results / Notices / News & Events pertaining to Counseling as CGDME will not be individually contacting the candidates for the same.

1) No communication will be directly sent to the Candidate(s). They are advised to be in touch with the website on a regular basis for any updates.

m) Court cases w.r.t. Counseling must be in the Hon'ble High Court Bilaspur jurisdictions area only.

n) Central Pool nomination seats are maintained by the Ministry of Defense, Ministry of External Affairs and other Ministries. CGDME has no role to play with regard to the same and the Counseling of the Central Pool seats is not conducted by CGDME. Candidates are advised to be aware regarding the same.

o) All admissions and resignations (if allowed) will be made through online mode only, no offline resignation of seat is permitted. Candidates must download the allotment letter from the CGDME counseling website only.

p) The security amount will be refunded (if any) to the same account from where the security amount was initially deposited by the candidate.

q) Candidates are informed that they can fill/update email Address and Mobile Number entries in the registration form as per their liking and OTPs will reach at the respective email IDs and Mobile numbers only.

r) Candidates are advised to use Laptop or Computer along with the latest registered version of Chrome/Internet Explorer/Firefox/Windows/IOS during the Registration and Choice-Filling process to avoid any technical complications.

s) Candidates are advised to download SANDES app for OTP on your

registered phone number for registration. This Might be useful for places where the network of registered mobile number is either not available or poor thus rendering the delivery of text messages difficult.

Please Note:

- **1.**All the documents regarding category (Caste certificate), EWS certificate, Class (PwD, Sainik, Freedom Fighter), Documents for verifying OBC Non creamy layer status, Domicile, Class 12th marksheet and other documents ascertaining the eligibility of the candidate must be dated before last date of the first scrutiny of the candidate. Once failed in the scrutiny of the documents, candidate will be ineligible for any further round of counseling.
- 2. Certificate ascertaining the disability of the candidate and eligibility for for medical seats under PwD quota must essentially be made by State Medical board only. No candidate producing district/any other medical board disability certificate will be entitled for seat under PwD class.

ROUND-1

a) Main counseling Registration which will include payment of Non-Refundable application fee and Refundable Security Deposit (to be refunded only in the account from which payment has been made and only if candidate is found eligible for refund of security deposit).

- b) Exercising of Choices and Locking of choices.
- c) Process of Seat Allotment Round-1
- d) Publication of result of Round-1on CGDME counseling website
- e) Reporting at the allotted Medical/Dental College: Candidates who have

been allotted a seat in round-1 can opt for willingness to upgrade from round 1 to round 2 for which they will have to physically report at the allotted college and get their documents verified by the scrutiny committee of Allotted Institute.

f) A candidate who has been allotted an institute (medical/dental) and unable to get his/her documents scutinized by the scrutiny committee or found unsuccessful will be ineligible for any futher round of counseling.

g) Admission at the allotted institute after successful scrutiny: After being successful in scrutiny of documents, taking admission is mandatory for candidates who have been allotted Govt Medical College only.

h) In case a candidate is allotted Private Medical or Govt Dental college or Private Dental College, the candidate is required to get document scrutiny only and they may choose to not getting admitted. However, they must give option for UPGRADATION if they want to upgrade to better preference.

i) All candidates can exercise their right to free exit without forfeiture of security deposit in Round 1 Only.

ROUND-2

a) Exercising fresh choices

b) Publication of result of Round-2 on CGDME counseling website.

c) Reporting at the allotted Medical/Dental College against Round 2

d) There will be forfeiture of security fees if a candidate is allotted an institute in round-2 (Govt or Private medical colleges) and he does not want to get admission or he gets admitted and resigns after that. He will also be ineligible for further round of counseling.

MOP – UP ROUND

Eligible candidates for Mop-UP Round

1. All registered candidates who have not been allotted any seat after the end of

Round 2 and thus not admitted in any institute.

2. Only those candidates who have been admitted in Govt Dental or Private Dental Colleges for getting admission in Medical Colleges are eligible.

3. For admission in Govt Dental or Private dental colleges, only those candidates remaining unallotted after round-2 are eligible for appearing in Mop up round.

Process of Mop up round:

i. Fresh choice filling of Mop Up Round

ii. Publication of result of Mop Up Round on CGDME counseling website

iii. Reporting at the Allotted Medical/ Dental College after Mop Up Round

FINAL STRAY VACANCY ROUND

• State Stray Vacancy Round for State contributed seats will be conducted by CGDME in compliance to Hon'ble Supreme Court judgement in Dar-Us-Slam Educational Trust Vs Medical Council Of India WPS Civil no. 267/2017 according to which Merit list containing Ten times the number of seats left in individual institutes will be sent to the respective college for scrutiny and admission before the last date of counseling as per National Medical Commision/ Hon'ble Supreme Court of India.
