Sub: Reduction of qualifying percentile for NEET-MDS, 2023.

Sir.

I am directed to say that this Ministry has decided to lower the qualifying cut-off percentile for NEET-MDS, 2023 by 31.807 percentile for each category (General, SC/ST/OBC and UR-PWD) in pursuance of DCI's MDS Regulations, 2017 and 2<sup>nd</sup> proviso in clause 7(1) of DCI's Master of Dental Surgery course (I<sup>st</sup> Amendment) Regulations, 2018. The qualifying percentiles for NEET-MDS, 2023, for the academic session 2023-24 now stand lowered as under:
