In pursuance of the Resolution passed by Government of India, Ministry of Women & Child Development and issued vide No. 4ord a of Hon'ble Supreme Court of India in a criminal appeal No. 135 of 2010 titled Budhadev Karmaskar V/s State of West Bengal, The Governor of Haryana is pleased to make a Scheme namely - "Rehabilitation of Female Sex Workers- Sexually Abused Women." to generate employment opportunities by providing various technical and vocational training to such women.

B Target Beneficiaries of the Scheme

The beneficiaries will be the female sex workers and sexually abused women. The beneficiaries will be identified by the agencies of State Govt, with the help of NGOs, expert Bodies and demographers.

C Objectives of the Scheme

- · To focus on the capacity building/ skill building and development for these women.
- To provide Industrial Training Institute to Sex Workers to make them self dependent.
- To provide for rehabilitation of the beneficiaries by providing them vocational / technical training through Women Development Corporation based and I.T.I's identified by Department of Technical Education.
- To provide assistance in securing loans for establishing self employment ventures to the women trained under the scheme.
- To provide back-ended capital subsidy on loans provided through Haryana Women Development Corporation.
- Arrange for sale of the products of the entrepreneurs assisted by the Department under the above scheme by organizing and Participating in Exhibitions/ Melas in collaboration with District Urban Development Authority /District Rural Development Authority/ District Red Cross Societies, Social Welfare Board, NGO, Industrial Training Institute or any other place etc.
- D <u>Training:</u>- The women will be provided skill development training as per need assessed.

The Department of Women and Child Development will bear the expenses of raw material trainer required, stipend to the trainees including other expenses through Women Development Corporation, Haryana Panchkula. The Department will also bear 100% actual expenses for conducting various training programmes.

2) Loan Provision

For those women who intend to start their own self employment projects, loans will be arranged through Nationalized Banks. The Corporation will provide interest subsidy of 5% subject to maximum of Rs. 10,000.

- The sponsoring of applications of eligible candidates may be done through Women Development Corporation, District Red Cross Society, Renowned Training Institutes, Experts and Trainers etc. In addition to this District, Administration can also identified the place for training and the trainers/resource persons.
- The Training Institutes will send the report to the District Manager, Haryana WDC about candidate who have joined training and are attending training courses. The Department will release the funds to the Corporation under subsidy component. The Corporation will release the funds to the concerned training institutes for paying out the stipend to the trainees. The Training Institutes will send the utilization certificate along with demand for the next quarter to the Women Development Corporation. The APRs will be maintained by the Training Institutes for the purpose of Audit etc.

The Women Development Corporation will process the loan cases for onward submission to nationalized banks and will release interest subsidy as per procedure.

G) Marketing of the products:-

The marketing of the products prepared by women can by through District Urban Development Authority /District Rural Development Auth aty or any other forum. The prepared goods/ items can be sold in various Exhibitions, Hatts/ Melas organized by district Administration or by NGOs. The district Administration will be involved actively at all the stages of implementation of the scheme.

H) Funding Pattern:-

A corpus will be created separately under the existing scheme Grant-In-Aid to the corporation (subsidy component). The corpus will be earmarked to implement the new scheme "Rehabilitation for Female Sex Workers - Sexually Abused Women".
