- c) Conduct in-depth analysis of the scheme performance and provide guidance to the relevant districts to ensure targeted performance levels.

d) Ensure public information, social audits, grievance redressal and other public accountability mechanisms.

e) Ensure fund availability in scheme account, internet connectivity and proper infrastructure at data entry level.

c. Capacity building at village level

No. 2063-SW(3) 2006.—The Governor of Haryana is pleased to constitute a Village Level Committee for the Development of Women and Children in order to ensure greater participation and ownership of village community leading to improvement in service delivery. The composition of the Committee will be as under :—

1. Lady Panch (to be nominated by Village Panchayat)	Chairperson
2. One lady school teacher (deputed by the Headmaster)	Member
3. Multipurpose Health Worker (female)	Member
4. Pardhan of Mahila Mandal	Member
5. SHG Leader (from each SHG)	Member
6. ASHA	Member
7. Representative of war widow, if any	Member
8. 3 Educated adolescent girls of which atleast one should be from scheduled caste	Member
9. Representative of NGO/Social activist working in the village, if any.	Member
10. Village Chowkidar	Member
11. All Anganwadi Workers	Member
12. Anganwadi Worker selected by the Supervisor	Convener

Functions :

- * The Committee will oversee village level implementation of all programmes relating to development of women and children and will receive feed back from beneficiaries under various programmes.
- * It will maintain 'Child Tracking' record in every village in the Anganwadi Centres in order to monitor every child's birth survival, nutrition, health, education and protection etc.
- * It will, in addition, deal with social issues pertaining to women such as domestic violence, dowry female foeticide, early marriage etc.
- * The Committee will meet atleast once a month and proceedings of the meetings will be recorded by the Convener in a register.
- * This Committee will *inter alia* act as Village Level Coordination Committee under ICDS.
- * It will also focus attention on those who are not availing of the initial services being provided by the Department.
- * The Committee would act as a catalyst in taking forward new initiatives such as supply of food items to Anganwadis through women Self Help Groups, mobilization of mothers to keep watch over quality of food and other services etc.
