- 1. You should know your name, address and parent's phone number in detail.
- Do not accept food offered by strangers.
- 3. You are the boss of your body.
- 4. Nobody is allowed to touch your body except your mommy.
- 5.Some body parts are private parts. They are private because they are not for everyone to see or touch.
- 6.No one should touch your private parts and no one can ask you to touch their body parts.
- 7. Having body secrets are not okay. Touching is never a secret. Brave kids discuss their body secrets with their parents and teachers.
- 8. No one is allowed to take photographs of your private parts.
- 9.It is okay to say 'NO' to an elder if you are not comfortable with him or her.
- 10. Always take permission from your parents before going anywhere alone without them.
- 11.If anyone threatens you, don't worry and talk to your parents about it.
- 12. Refuse hugging and kissing from strangers and whenever you feel uncomfortable.
- 13. You don't have to be polite and quiet if someone scares you. It's okay to say a NO.
- 14.If you are ever lost in a marketplace, call childline 1098 for immediate help.
- 15.If someone tells you to disobey the instructions of your parents, then it is wrong. Never disobey your parents to trust a stranger.
- 16.Trust your parents and teachers for your secrets. They are the best people to keep your secrets.
- 17.Do not eat food given to you by strangers. Good children eat safe and healthy food given by parents.
- 18. Childline 1098 is your telephone buddy. If you face any problem, call 1098 for immediate solution.
- 19. You have an 'identity'. Know all the details of your identity and ask your parents about it.
- 20.Discussing your friend's secrets and problems with your parents and teacher is a nice thing to do. You can help your friends this way.
