### **REVIEW OF THE ANNUAL ADMINISTRATIVE REPORT OF THE DEPARTMENT OF WOMEN & CHILD DEVELOPMENT, HARYANA FOR THE YEAR 2011-12.**

Various schemes for women & child development implemented directly by the Women & Child Development Department, Haryana under state and central sectors and through Haryana Women Development Corporation, Haryana State Social Welfare Board and Haryana State Commission for Women and NGOs by providing financial assistance.

#### **BUDGET**

Originally, a budget allotment of Rs. 54638.85 lacs was made in the year 2011-12 under various schemes and heads, which was revised to Rs 60042.62 lacs. Expenditure of Rs. 51076.18 lacs incurred under different schemes and activities, out of which Rs. 17906.13 lacs were under State Plan, Rs. 24075.38 lacs under Central Plan and Rs. 9094.67 lacs under Non Plan heads.

#### **Schemes and Programmes**

The following programmes, schemes and activities implemented during the year 2011-12 for the welfare, development, progress and empowerment of women and children:

1. Under the incentive based scheme '**Ladli**' a sum of Rs 5352.21 lacs spent during the year 2011-12 and 153179 families/girls benefited including 129261 beneficiaries of previous year
2. '**Integrated Child Development Services Scheme**' is the biggest scheme of child development being implemented in 148 blocks including 18 urban blocks under which 11.46 lacs children between 6 months to 6 years of age and 3.26 lacs pregnant and nursing mothers have been provided supplementary nutrition and other services through 25223 Anganwadi Centers in an integrated manner.

To make ICDS programme a community driven and a decentralized programme, the State Govt. has set up 6033 **Village Level Committees** of women under Panchayati Raj Act 1994. The State Govt. has released Rs 5.00 lacs for providing assistance to VLCs for their sustainability.

To lend necessary resource support to Gram Panchayat and its sub committee for effective discharge of functions assigned to them, a rural NGO named as **Sakshar Mahila Samooh (SMS)** formed by the State Govt., which is consisted of all educated women of the village. Sakshar Mahila Samoohs create awareness regarding the key social issues like sex ratio, literacy, universalization of elementary education, health and nutrition education, opportunities for economic empowerment for women, hygiene, sanitation and environment and schemes run by the Government for women, girls, children and village community. During the year, about 6279 SMSs have been registered & an amount of Rs. 5.00 lacs was spent.

26 Anganwadi Workers were given State Level Awards @ of Rs. 5000/- each for their exemplary performance in ICDS services and names of three AWWs have been recommended to GOI for National Award.

34636 Anganwadi Workers and Helpers have been insured under the scheme named **Anganwadi Karyakatri Bima Yojna** under Social Security Group Scheme of the Life Insurance Corporation of India.

Under **Training Programme** for ICDS functionaries, a sum of Rs 130.29 lacs has been released to Anganwadi Workers Training Centers, one Middle Level Training Centre and for other trainings.

The scheme of Construction of Anganwadi Centers was implemented under which a sum of Rs 1598.00 lac has been released to Additional Deputy Commissioners to construct 188 Anganwadi Centers under economic stimulus programme.

**Incentive Awards for improvement in Sex Ratio** @ of Rs. 4.00 lacs given to district Ambala for 1st position, 2.00 lac each to district Bhiwani and Mewat for obtaining 2<sup>nd</sup> position and 3<sup>rd</sup> award of Rs. 2.00 lac given to district Rewari

**District level Awards for improvement in Nutritional Status** @ of Rs. 2.00 lacs, Rs. 1.00 lac, & Rs. 50000/- given 1<sup>st</sup> to Sonapat, 2<sup>nd</sup> to Rewari and Panipat, 3<sup>rd</sup> to Palwal and Hissar districts for securing 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> positions respectively.

3. **'Kishori Shakti Yojna'** implemented in 128 ICDS projects to improve health and nutritional status of adolescent girls and a sum of Rs. 289.00 lacs, was spent on providing supplementary nutrition to 53697 and training to 53633 Girls respectively

4. **Rajiv Gandhi Scheme for Empowerment for Adolescent Girls SABLA** has been launched in six districts Ambala, Hissar, Rewari, Rohtak, Yamunanagar and Kaithal 78341 girls has been provided Supplementary Nutrition Programme (SNP) under this scheme.

5. **Integrated Child Protection Scheme** implemented under which various scheme for children in need of Care and Protection and for juveniles in conflict with law will be covered. This programme is being implemented through Haryana State Child Protection Society and State Project Support Unit.

6. In order to encourage rural girls for pursuing higher education, the scheme of **'Awards to Rural Adolescent Girls'** has been started under which, 3 rural girls who have passed the matriculation examination from Haryana School Education Board from each block are given awards of Rs. 2000/-, Rs. 1500/- and Rs. 1000/- securing 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> positions respectively.

7. To reduce malnutrition among children, the scheme of **'Improving Infant & Young Child Feeding'** has been implemented by the state Govt., under which Anganwadi Workers are being trained to equip them with knowledge and skill of infant and young child feeding practices enabling them to create awareness and make counseling of mothers more effectively.

8. To encourage women for proper rearing of their children, especially the girl child, with a view to improve their nutritional and health status, the scheme of **'Best Mother**

**Award** has been implemented. During the year 2011-12, a sum of Rs 21.76 lacs has been spent and 3438 mothers have been given awards.

9. Under the scheme of '**Annual Sports Meet for Rural Women**', opportunities of sports and recreations have been provided to rural women for their empowerment and capacity building at block level. A sum of Rs 23.15 lacs has been spent under ICDS scheme and 3297 prizes were given to the women.

10. Under the scheme of '**Gender Sensitization**' 3 master tainer training course were organized in distt. Kurkshetra, Hissar, Jind through Women Study and Research Centre, Kurukshetra and 128 Block level two days workshops organised in these distt.

11. Financial assistance in the shape of '**Grant-in-Aid**' to the tune of Rs. 709.60 lacs has been given to Voluntary Organizations for running training centers for women and child welfare activities.

12. '**The Dowry Prohibition Act**' is being implemented in the state. Further steps have been taken to implement the Dowry Prohibition Act more effectively.

13 Under the '**Protection of Women from Domestic Violence Act**', 2005 Child Marriage Act Protection Cum Child Marriage Prohibition Officers has registered 2299 complaints for aggrieved women and 388 complaints of child marriages.

14 The department implemented various schemes for creating awareness amongst rural women for their development and empowerment by encouraging and promoting '**Mahila Mandals**'. During the year 2011-12, a sum of Rs 108.00 lacs has been spent on the scheme of Promotion and Strengthening of Mahila Mandals.

15. For speedy disposal of family disputes, the State Govt. has sanctioned 4 '**Family Courts**' at Faridabad, Gurgoan, Hisar and Bhiwani to be set up in phased manner.

16. '**Haryana Women Development Corporation**' arranges institutional finance for vocational training and self employment of women to ameliorate the socio-economic conditions of women.

17. A State Training Institute called "**WAMA**" Women's Awareness and Management Academy, upgraded as 'Regional Level Gender Training Institute' is being run at Rai (Sonapat) for providing training to grass root level women workers and training on gender sensitization .

18. The State Govt. set up '**Haryana State Commission for Women**' in the year 1999-2000. Steps have been taken by the commission to redress the grievances of women suffering from atrocities. During the year 2011-12, a sum of Rs. 52.00 lacs has been released to the Commission by the State Govt.

19. Haryana Government constituted a '**State Mission for Empowerment of Women (SMA)**' for empowering the women sourly, economically and educationally as well as effective implantation of various social laws for concerning the women under the chairmanship of Chief Ministry Haryana.

20. During the year, grant-in-aid worth Rs.35.72 lacs has been released to the **'Haryana State Social Welfare Board'** for headquarter establishment expenditure and Chairman's allowances etc.

## CRITIQUE

The Women and Child Development Department, Haryana has implemented various schemes and programmes to improve the status of women, children and adolescent girls by providing them various types of services and facilities under different schemes.

In order to combat the problem of declining sex ratio in the state, an incentive based scheme 'Ladli' has been implemented by the State Govt., under which a sum of Rs. 5000/- is invested in Kisan Vikas Patras (KVPs) per year, for five years, on the birth of second daughter born on or after 20-8-2005, which will be provided to the tune of Rs 96,000/- (approx) on maturity after 18 years.

The scheme of Awards to Rural Adolescent Girls implemented to encourage rural girls for pursuing higher education.

To reduce malnutrition among children, Anganwadi Workers have been trained to equip with knowledge and skill of infant and young child feeding

The scheme of Best Mother Award has been implemented under which mothers are given prizes for better care of child especially girl child.

The scheme of Annual Sports Meet for Rural Women was implemented to provide opportunities of sports and recreations to rural women.

Gender Sensitization training has been imparted to Panches and Sarpanches, Medical Officers/ Health Functionaries and Police Personal.

Integrated Child Development Services Scheme is the biggest scheme of child development was implemented in 137 blocks including 18 urban blocks under which the package of services of Supplementary Nutrition, Immunization, Health Check Up, Referral Services, Health and Nutrition Education and Non-formal Pre-School Education provided to six months to six years old children, pregnant and nursing mothers.

To lend necessary resource support to Gram Panchayat and its sub committee for effective discharge of functions assigned to them, a rural NGO named as Sakshar Mahila Samooh (SMS) has been formed. These SMSs create awareness regarding key social issues like sex ratio, literacy, universalization of elementary education, health and nutrition education, opportunities for economic empowerment for women, hygiene, sanitation and environment and schemes run by the Government for women, girls, children and village community.

Under the Training Programme for I.C.D.S. functionaries, funds released to Anganwadi Workers Training Centres and one Middle Level Training Centre.

The scheme of Construction of Anganwadi Centres was implemented under which funds released to Additional Deputy Commissioners to construct Anganwadi Centres.

Incentive Awards for improvement in Sex Ratio and in Nutritional Status Awards given to districts for securing 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> positions.

Kishori Shakti Yojna was implemented in 128 ICDS Projects to improve health and nutritional status of adolescent girls. Under this scheme, adolescent girls have been provided supplementary nutrition and training in life development skills.

Rajiv Gandhi Scheme for empowerment for Adolescent Girls (SABLA) has been launched in six districts Ambala, Hissar, Rewari, Rohtak, Yamunanagar and Kaithal.

Financial assistance in the shape of grant-in-aid was provided to Voluntary Organizations for running training centers for women and child welfare activities.

Steps have been taken to implement the Dowry Prohibition Act more effectively in the state. Under Protection of Women from Domestic Violence Act, the State Govt. has decided to appoint Protection Officers and registered Service Providers for providing necessary assistance to the aggrieved persons in the state.

Activities for awareness generation against social evils like dowry, female foeticide and child marriage and publicity of the departmental schemes have been made through posters, pamphlets and through press note etc.

Haryana Women Development Corporation arranged institutional finance for self employment of women.

JJ Act 2006 is being implemented in the state for the care and protection of children.
