#### Introduction

#### Background of Women & Child Development Department (WCD)

The Directorate of Women and Child Development is functioning w.e.f 1.4.92 vide notification no.79-SW 1/92 dated 10<sup>th</sup> February, 1992 after getting bifurcation from Social Welfare Department. In its capacity as a nodal agency looking after the advancement of Women and Children, the Department formulates plans, policies and programmes and coordinates the efforts of both government and non-governmental organizations working in the field of Women and Child Development. The Department is implementing various schemes of State and Centre for overall care, development and protection of women and children. The Directorate is also administratively responsible for Haryana Commission for Protection of Child Rights, Haryana State Commission for Women, Haryana Women Development Corporation and Haryana State Social Welfare Advisory Board.

#### The Vision of WCD

- i. Facilitate women to become economically and socially empowered, so that they contribute as healthy and equal partners in an environment free from violence and discrimination.
- ii. Provision of opportunities to children and adolescent girls for growth and development to the fullest in safe and protected environment.

#### The Objectives of WCD

i. To lay the foundation for development of children below 6 years with focus on nutrition, health and non formal pre-school education and

awareness and capacity building for mothers about nutritional and health needs of the child.

- ii. To empower adolescent girls (11-18 years) through nutrition, health care and life skill education.
- iii. To provide a safe and secure environment for overall development of children who are in need of care and protection and those in conflict with the law.
- iv. To create awareness and to provide support services to aggrieved women/families, protection of women from Domestic Violence Act 2005, Dowry Act 1961.
- v. To create awareness and to implement the provisions of Juvenile Justice (Care and Protection of Children)Act, 2015 and Model Rules 2016, The Protection of Children from Sexual Offences Act, 2012 and The Prohibition of Child Marriage Act, 2006.
- vi. To provide support services to children, who are in need of care and protection and those in conflict with the law as laid under Juvenile Justice (Care and Protection of Children) Act, 2015 and Model Rules 2016, The Protection of Children from Sexual Offences Act, 2012 and Integrated Child Protection Services.
- vii. To remove the bias against girl children, to correct adverse sex ratio and eradicate social evils affecting women adversely.
- viii. To prevent women and children from being abused and trafficked.
  - ix. To enable Economic and Social Empowerment of women to provide relief and rehabilitation to vulnerable and disadvantaged women including skill development and economic development.
  - x. To create awareness about gender concern in policies and schemes of Govt. and to undertaken research training and capacity building as well as improvement in internal mechanism for better understanding of issues

related to women and children and to improve efficiency in delivery of services.

xi. Prove efficiency in delivery of services.

#### **Objectives of Request for Proposals (RFP)**

Children between the age of 12-18 years are considered as the period of adolescence, which is a most vulnerable age. These children are on a higher risk of being left out of the system of formal education and employment, keeping them away from any opportunities. Children who have to leave an Child Care Institution (CCI) on attaining the of 18 years, as per the provisions of JJ Act, 2015, a programme is to be prepared through which further education, employable skills and placement can be given.

In order to prepare children for economic independence when they attain the age of 18 years, there is a need to give them employable skills/skill training or vocational training which will lead to their empowerment and independence and their re-integration into the mainstream of the society.

#### **Provision of Juvenile Justice Act 2015**

Section 37 of Juvenile Justice Act 2015 talk about Vocational Training which is reproduced as under:-

- 1. Every Child Care Institution shall provide gainful vocational training to children according to their age, aptitude, interest and ability, both inside to outside Child Care Institution.
- 2. Vocational training shall include occupational therapy, skill and interest based training, aimed at suitable placement at the end of the course. The institute preferably government recognized, providing vocational training shall give a certificate, on the completion of the3 course.

- 3. Where vocational training is offered outside the premises of the Child Care institution, children shall be escorted for such programmes with proper security planning end service, particularly for children who are at risk.
- 4. A record shall be maintained for all children attending the programmes and the progress made by each child shall be reviewed. The report in that regard shall be submitted to the Board or the Committee or the Children's Court, as the case may be, on a quarterly basis

#### **Guidelines of Child Protection Services**

Children who are discharged from the institutions as a youth adults, every institutions should tie up with local NGOs and ITIs to either provide Vocational facilities within in the institutions or send the children to such NGOs or ITIs for specialized vocational training for which the child has an aptitude. #### Status of Children in Haryana for Skill Training

As per the data available, approximately 1050 children in the age group of 14-18 yrs and 18 years above require skill training. The number of children residing in the Child Care Institutions (Observation Homes, Special Homes, Place of safety for children in conflict with law and children Homes for Children in need of care and protection) may vary from time to time.
