TERMA AND CONDITIONS:-

- That the appointement to the psot of Group-D is purely on temporary basis/provisional basis. This post is liable to be abolished at any time and carried no promise of subsequent permanent employment. No offer on permanent vacancy can be made to you at present and in this respect the candidate will have to take his/her chance like others who have been similarly recruited.
- That you will remain on probation for a period of two years which may be extended upto three years. During the period of probation, leave as per Haryana Govt. Rules will be permissible. However, in case of illness, your case of leave will be considered on production of a Medical Cerificate issued by an authorized Medical Attendant. If, during or at the end of this period of probation your work and conduct is not found satisfactory, your services will be liable to be dispensed with/without any notice or assigning any reason.
- 3. That your appointment is subject to the condition that your document pertaining to your Quilification, Experience, Age and Caste/Category, as claimed by you in the application form will be got verified from the concerned issuing authorities. Therefore, you shall have submit an undertaking at the time of joining that in case your documents as claimed by you in application form is found fake, your services will be terminated without assigning any reason and without giving any prior notice. Besides, criminal action will be taken against the defaulter. Further, you shall have to produce the above original certificates to concerned Head of office at the time of joining.
- 4. That you will be covered under New pension Scheme of Haryana Govt. which is in force w.e.f.01.01.2006.
- That in case, at any stage, while you remain in temporary capacity& desire to resign your post in the Women and Child Development Department you will be required to give one month's notice or forfeit in lieu therof, salary including allowances for one month or for the period by which th notice falls short of one month. Such a notice can also be given to you by Government in case it is proposed to terminate your services for reason other than mentioned in pera(1) above. Government will also be liable to pay salary including allowances for one month or for the period by which the notice falls short of one month. In case of misconduct, you will be given a reasonable opportunity to show cause as to why your services should not be terminated, in that case the condition of one month's notices shall not apply. Your services will be governed by the 'Haryana Group –D employed (Recruited and conditions of service)Act,2018 and 'Haryana Civil servies(P&A) Rules2016' Departmental service Rules and anyother instructions issued by the Haryana Government from time to time.
- 6. That you will not undertake higher studies any kind without obtaining prior permission of the competent authority. Consequently, no leave except examination date of any kind will be granted to them for the purpose of higher studies.
- 7. That will be required to take the prescrivbed oath of alleginave to the constitution of India.
- 8. That in case, you are marred, you will have to give a declaration that you are not having more than one living spouse & you are not married to a person having a living spouse.
- 9. That no T.A./DA/ joining time will be granted for joining this post.
- 10. That as your character and antecedents have not been got verified in trems of Government instructions issued vide Memo No.52/03/2005-6S(1) dated 18th November,2005, therefore, it is made clear to you that in case subsequently any advers facts come to the notice of the State Government regarding your character and antecedents, your services will liable to be terminated without giving any notice.
- 11. You are required to furnish a Medical Certificate of Fitness before joining from the Medical Board constituted under rule 9 of Haryana Civil Services (General) Rule, 2016. You should appear for medical examiniation in the office of concerned Civil Surgeon.
